



BYLAW NOTICE

NOTICE OF THE PASSING OF ZONING BY-LAWS BY THE CORPORATION OF THE CITY OF MISSISSAUGA

TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-laws 142-99, 143-99 and 144-99 on the 31st day of March, 1999, under Section 34 of the Planning Act, R.S.O., 1990, c.P.13, as amended.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the By-laws by filing with the Clerk of the City of Mississauga not later than the 27th day of April, 1999, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, together with a cheque in the amount of \$125.00 for each of the By-laws payable to the Minister of Finance.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

BY-LAW 142-99

EXPLANATION OF THE PURPOSE AND EFFECT OF THE BY-LAW

That Zoning By-law 5500 be amended by adding the following requirements for night clubs:

- . Night Clubs are restricted to a maximum gross floor area of 1 115 m² (12,002 sq. ft.)
- 2. Night Clubs shall not be located closer that 800 m(2,625 ft.) to the lot line of a residential zone or an agricultural zone.

Politician offers much input at public meeting by police

Miltonians want to see more police officers and better response times, a local councillor told police-hired consultants at a public meeting Wednesday.

Regional and town Councillor Rick Malboeuf told the meeting held to gain input on public opinion of Halton police that he hasn't heard any complaints about officers' professionalism or abilities, just that there aren't enough of them on the road.

"When you're doing a seat belt blitz there's five or six cars and people say, where are they when you need them?"


He said Milton has the least amount of officers in the region, yet the largest land mass and the most roadways.

He also complained that there's no Milton representation on the Halton Regional Police Services Board.

The Halton Regional Police Service is currently undergoing a review to determine multi-year policing resource requirements. It has hired the consulting firm Perivale and Taylor to conduct the review.

Attempting to determine how the Halton Regional Police Service can best meet the safety and security needs of the region, Keith Taylor of the firm said the issue is complex.

"There's no global answer on how to define effectiveness and efficiency," he said in his introduction, which was followed by questions posed to meeting

participants.

Many questions centred around what citizens would expect in return for a tax increase.

Mr. Malboeuf said he couldn't use growth to justify an increase in the police budget.


Citizen Mary Chisholm said she believes Halton police officers generally have an exceptional rapport with the public, but warned that with a mega-jail and casino about to open, stepped-up police enforcement will be needed.

"We know there's going to be problems," she said.

Despite a newspaper advertisement and news coverage notifying the public of the Milton meeting, Ms Chisholm was the only private citizen to attend.

In addition to Ms Chisholm, the meeting consisted of two consultants, two police officers, a civilian police employee, a Champion reporter and Mr. Malboeuf, who offered his perception of concerns in
