

# Hawks shade improved Reding by a single run

Bishop Reding's girls softball squad is still looking for their first win of the season — but they are making progress in the search.

The Royals have made significant improvements in every area since last week's home opener. This overall headway nearly translated into victory at Lions Sport Park Tuesday, when they were nipped 9-8 by Oakville's Loyola Hawks.

Activated from the disabled list, veteran pitcher Carolyn Coates made her debut on the hill. While noticeably rusty from such a lengthy layoff, she did show strongly in the first frame and struck out a handful of batters overall.

Meanwhile, Heather Townsend was sure and steady in three innings of relief — surrendering just two runs on three hits while working herself out of a serious jam in the third.

BR's solid, if not spectacular, pitching campaign was coupled with their finest

offensive performance to date.

Leading at the plate was right fielder Stephanie Pender, who went 4-for-4 with a couple of extra base hits and three RBI, including two in the Royals' final at bat.

The local team cut a late deficit from four to one and had the tying run at second base with none away in the last inning before Loyola's infield unit made three straight put-outs to finally end their comeback bid.

Left fielder Sara Wood drove in first and fourth inning runs while other RBI were posted by Townsend, shortstop Stacie Haringa and third-baseman Jen McBean.

Bishop Reding's defence was fairly decent, with only three errors made on the afternoon. Infielders were kept busy as the Hawks managed several short hoppers in no-man's land that had to be chased down.

The 0-3 Royals were off yesterday but resume league play this coming Tuesday, May 11, when they begin a five-game road trip against Oakville's Iroquois Ridge Trailblazers.

The three-year-old bay filly by Dragons Lair had to fight back to earn the lion's share of the \$54,500 purse.

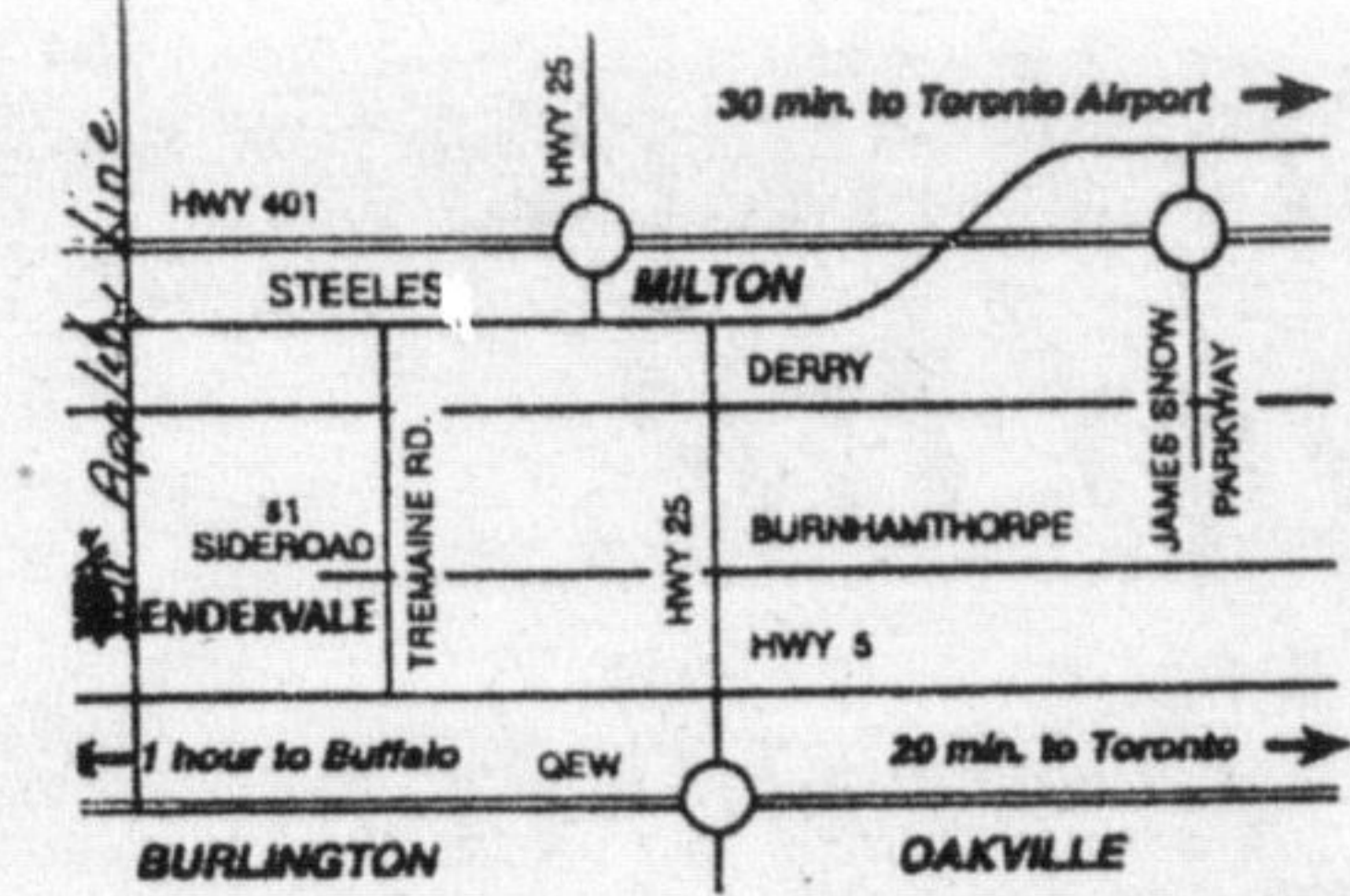
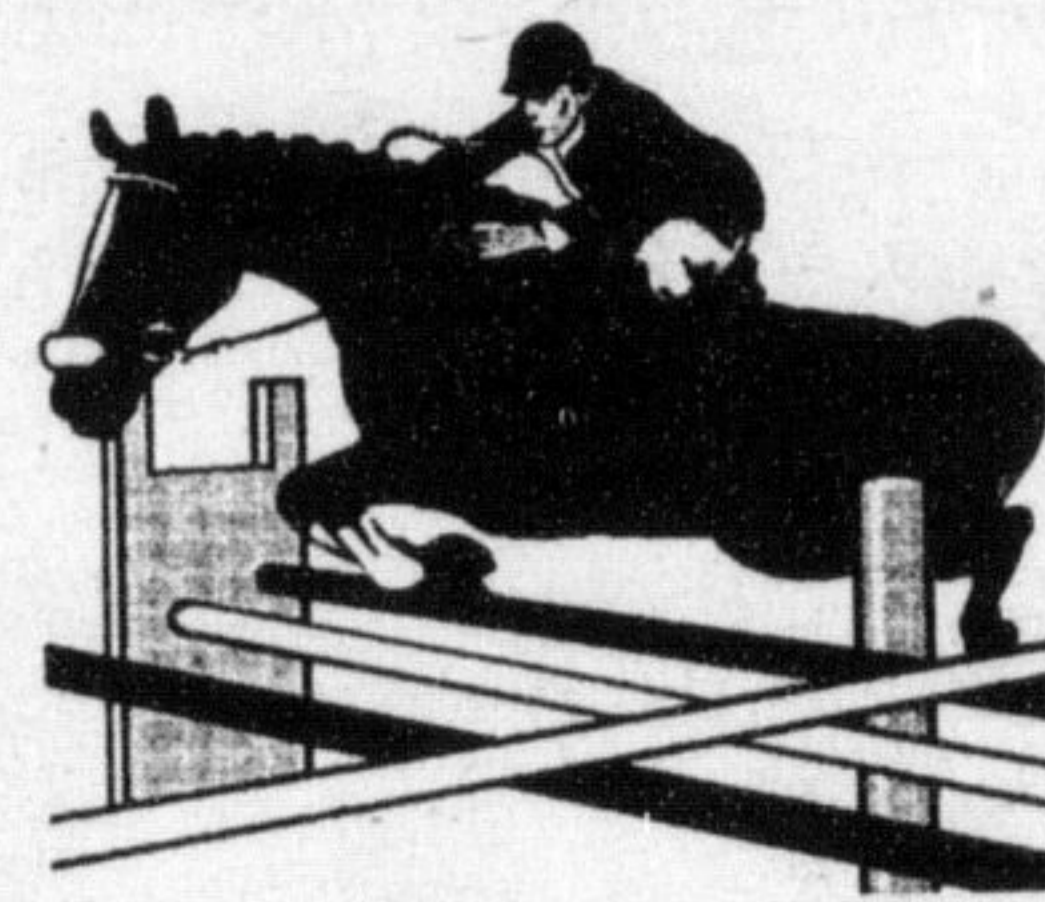
After leaving hard from the rail post, she reached the opening quarter in :26.4. Paul MacKenzie, driver of R.L. Annie H, then

#### Halton Urban Structure Plan Servicing Revisions

The Halton Urban Structure Plan set out a process to provide servicing infrastructure for the Region of Halton's response to pressures for new urban growth. Projects listed in the Water and Wastewater Servicing Master Plan Review, 1998 were planned in accordance with the Class Environmental Assessment for Municipal Water and Wastewater Projects. A review of the Master Plan is being undertaken to address a small number of revisions to projects which are to be built for the first phase of development in Milton and Halton Hills (6,200 new homes and 500-700 acres of employment lands). In accordance with the commitments set out in the Master Plan, the Region proposes to amend the Master Plan.

#### The following recommended revisions include:

- New Elevated Water Tank:** the addition of new elevated water tank in Milton in order to provide a separate Lake Ontario water supply in Milton for new residents
- Fourth Line Wastewater Main revisions:** relocation of the proposed Fourth Line wastewater main in Milton
- New Pumping Station at new Mid Block Collector Road:** the addition of a new wastewater pumping station in Milton east of 16 Mile Creek, between Derry and Britannia Roads
- Regional Road #25 Intermediate Wastewater Pumping Station:** revisions to the proposed location of a wastewater pumping station in Milton from north of Lower Baseline Road onto the Region's Waste Management Site
- Fourteen Mile Creek Wastewater Main and Pumping Station Revisions:** relocation of the proposed wastewater main from east side to west side of Fourteen Mile Creek, south of Upper Middle Road and a new pumping station at the Mid Halton Wastewater Treatment Plant in Oakville

These revisions are to provide a cost effective servicing strategy for urban expansion areas entirely within Halton Region in a timely manner with least environmental impact and community disruption.

#### Milton Wastewater Treatment Plant Re-Rating

The Region is also conducting a public meeting pursuant to the requirements Schedule C of the Class Environmental Assessment for Municipal Water and Wastewater Projects to review the Region's plans to seek additional wastewater treatment capacity at the Milton Wastewater Treatment Plant. The Region proposes to use the membrane bioreactor technology, recently demonstrated at the Plant, to expand the capacity by 1,000 m<sup>3</sup>/d. The objective of the study is to increase capacity while maintaining the water quality in Sixteen Mile Creek.
