## We don't want our town to become another Brampton

Dear Editor:

Today I became aware of the proposal to extend James Snow Parkway between Fourth Line and Fifth Line in the Milton area. I am writing to express my concerns.

According to the James Snow Parkway Environmental Assessment Study — Environmental Study Report prepared by McCormick Rankin Corporation (MRC) (page E-2), "On the basis of investigations carried out during the study by specialists, it is not expected that there will be any significant effects, resulting from the recommended improvement plan, that cannot be mitigated."

I can't quite see how building a four-lane roadway on farmland and through woodlots from Milton to Oakville, across the east Sixteen Mile Creek could not have significant environmental effects. I can't see how a road that is to be built to accommodate the expansion of Milton by 50,000 people could not have significant environmental effects. But then, I'm not a specialist.

I remember David Suzuki saying that, although he spent years studying the fruit fly and was considered to be an expert on it, he really didn't understand the first thing about it. He found it absurd that humans could be so arrogant as to believe that they could even begin to understand the environmental impacts of their actions.

The report states that the plan "has general support from the community." Well, it doesn't have my support, and I would suggest that the only reason MRC thinks it does have general support is that most of the community are unaware of the situation or believe there is nothing they can do about it.

The people I talk to all say the same thing: they like the "smalltown" feel of Milton, they don't want it to become another Brampton or Mississauga, and they wonder who does support the proposed expansion.
