## Deoni has new lawyer, case is still dragging on

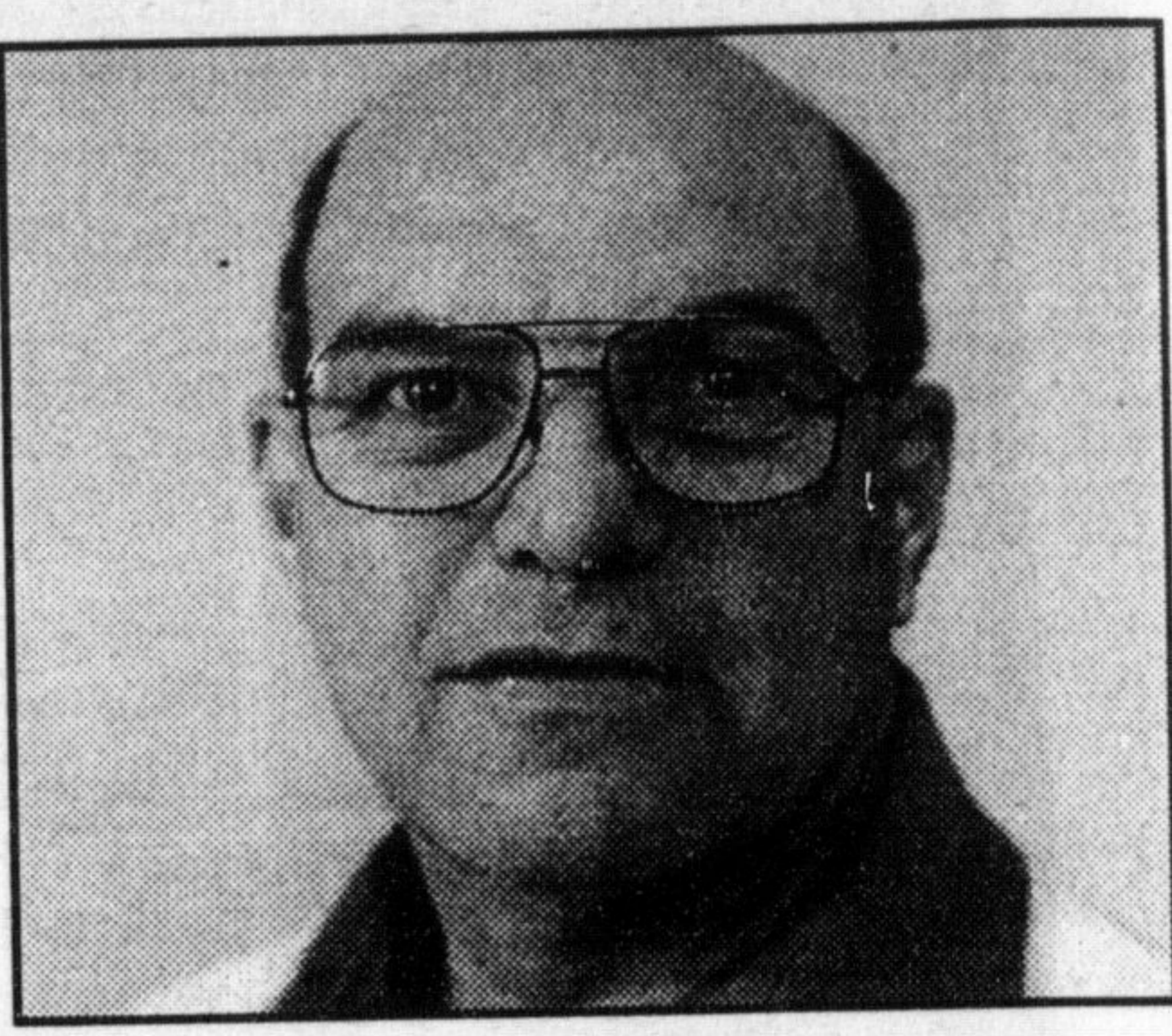
Catholic school Trustee Joe Deoni — who faces fraud charges — put off setting a trial date Monday due to a change in legal counsel.

Since last appearing in court in April, Mr. Deoni has retained P.G. Di' Martino as his new lawyer, who in Ontario Court (general division) asked the judge to give him time to review the case.

The Crown Attorney didn't object and the request was granted. Mr. Deoni, who was acclaimed in 1997 to the position of Milton school trustee (English) for the Catholic District School Board, was order to stand trial following a preliminary hearing March 25. He has elected a trial by jury.

He was charged last March with fraud over \$5,000 following a two-month Halton Regional Police investigation.

He will now return to court September 7 to set a trial date.

## Seniors felt bulldozed by EC Drury protesters

Older residents don't want to be run out of town over a lack of seniors' housing, Milton council heard Monday night.

That was the message from several seniors who tendered support for the proposed development behind the E.C. Drury school complex.

The proposal has been bitterly contested by residents, many of whom feel the site should be retained as parkland.

They were given an opportunity to air their beefs on the matter at a public meeting on May 26.

At that time, opponents of the development expressed their views by stamping, cheering and heck-

ling. The furor drowned out the voices of seniors, said resident Marian Pearce.

"After attending the May 26 meeting, I was left with the impression that the loudest opinion was heard," she said.

That meeting ended with a vote by the Town's administration and planning committee to slam the door on the proposed residential development.

After some confusion over procedure, that decision was upheld at the June 7 council meeting.

A 180-bed nursing home is still being considered for the site, which is the largest open green space in urban Milton.

**PROPOSED RECONSTRUCTION OF GUELPH LINE (REGIONAL ROAD NO. 1) FROM 250 m NORTH OF NO. 10 SIDEROAD TO 220 m NORTH OF 15 SIDE ROAD (REGIONAL ROAD NO. 15) TOWN OF MILTON PR-0928B&C**

The Regional Municipality of Halton is proceeding with the detail design to reconstruct the Guelph Line to a two-lane roadway within the project limits in order to provide improvements to roadway geometry, sight distance, safety and pavement structure. Separate northbound and southbound left-turn lanes are planned for the intersection of No. 15 Sideroad. Construction will be phased over a two-year period and is tentatively scheduled for the years 2000 and 2001. The preliminary design for this section of Guelph Line has been completed and the design is proceeding with detail design.

Public input and comments received at the last Public Information Centre held on November 24, 1998 have been considered and where feasible incorporated into the Guelph Line design.
