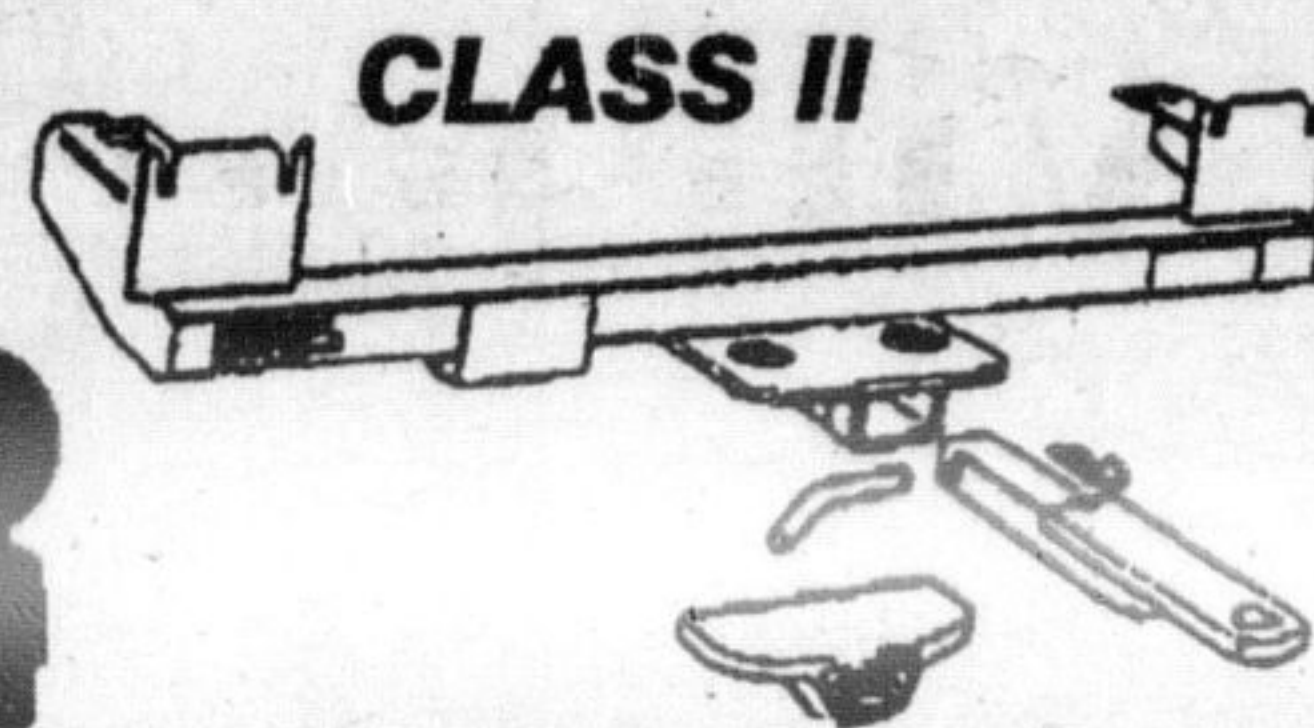
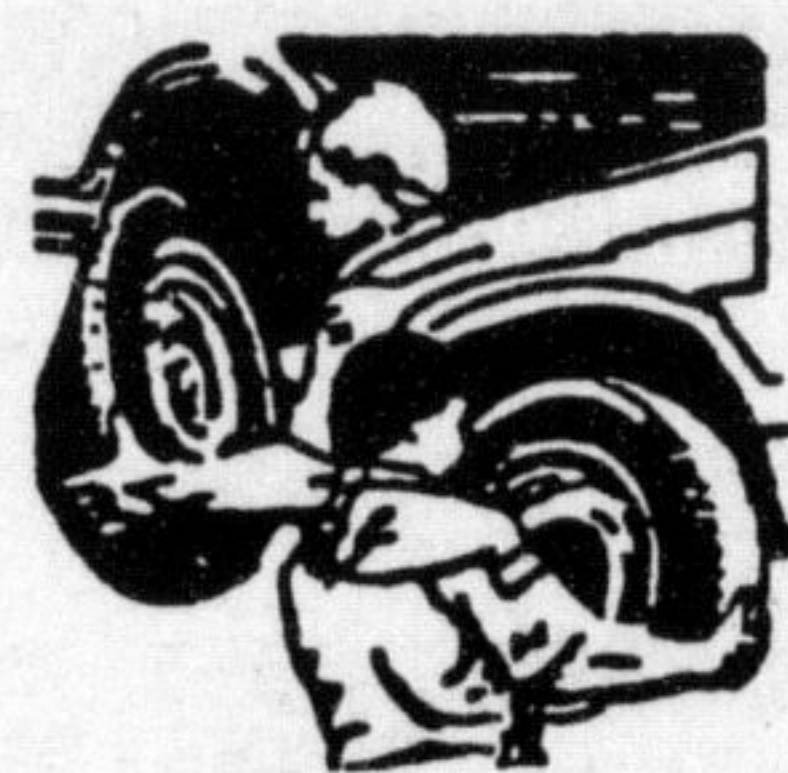

## Stolen car used to force open door in stereo store break-in

Thieves used two stolen vehicles to help them commit a break-in at the Sound Man on Main Street East early Monday morning.

Halton Regional Police determined the culprits drove a blue Chevrolet van stolen from Campbellville into a large rear door to gain access to the store shortly after 4:15 a.m.

Inside, the thieves took stereo equipment and four amplifiers worth \$2,000, said Det. Sgt. Jackie Gordon.

Left at the scene was the van as well as a Plymouth Sundance stolen from Woodward Avenue.

### Cash stolen

About \$600 in cash went missing Saturday as a Milton Mall shoe store clerk emptied the tills.

The Payless Shoe Source clerk left money from one till unattended in a back room for a short time while she attended to another till.

When she returned, the cash was gone, Det. Sgt. Gordon said.

The incident occurred sometime between 5:45 and 6 p.m.

Police are investigating.

### Convenience store break-in

A citizen witnessed thieves break into Farah's Food Mart at Laurier Plaza early Wednesday morning.

Two trays of scratch tickets worth \$340 were stolen at 1:30 a.m. after one culprit kicked the front door until it smashed.

The suspect escaped in an awaiting vehicle believed to be a Ford Tempo or Mercury Topaz. The car was last seen travelling eastbound on Laurier Avenue.

### Man charged in car heists

A man faces several charges of theft under \$5,000 after numerous cars were broken into on Main Street.

One of the break-ins occurred sometime between 1:22 and 1:40 p.m. Saturday in the rear parking lot of the Waltzing Weasel.

Some loose change and liquor was taken from a 1984 GMC pickup truck left unlocked, police said.

A 48-year-old man of no fixed address is charged.

Information concerning the other break-ins wasn't available at press time.

### Plywood stolen

Someone made off with 100 sheets of plywood from a house construction site on Pineridge Drive.

The \$2,500 worth of wood went missing sometime between 3 p.m. last Friday and 7 a.m. Saturday.

### Stolen car recovered

### Shoplifters at work

Police are warning merchants to be on the lookout for a team of shoplifters who recently went to work in town.

The team consists of two males and two females with dark complexions in their thirties or forties, said Det. Sgt. Gordon.

The culprits went to work at Home Hardware on Steeles Avenue Monday shortly after 6 p.m.

Two members of the group distracted the clerk while the other two hid items under their clothing and left the store.

The same people were also spotted at Cashway Building Supply, where it's believed the women concealed items under their dresses.

### Truck stolen

A Mack truck valued at \$45,000 was stolen from the Fifth Wheel Truck Stop early Monday morning.

The vehicle that had 'Lacroix' painted on the side was taken sometime between 1:30 and 3:20 a.m.

**Pre-Authorized Tax Payment Program (PTP). How it works**  
The PTP program provides for taxes to be automatically withdrawn from your bank account a) on the first business day of each month from January to October (Monthly Tax Payment Plan) or b) on each of the four regularly scheduled instalments (February, April, June and September). (Due Date Tax Payment Plan).  
**You are eligible if all taxes due prior to enrollment in the PTP Program have been paid.**

- How it works**
1. Your application, along with a void cheque, must be received by October 15th of this year in order to begin withdrawals for the next year.
  2. Upon entry into the program, a statement will be mailed advising of instalment details for the interim billing period.
  3. In the month of June, you will receive a notice advising of the monthly instalment amount of the final billing. The amount will be based on the current tax rate minus payments made from January to June.
  4. A receipt for the year's total payments will be enclosed with your interim billing notice for the following year.

**Bank Account Changes and Program Withdrawals**  
For changes or withdrawal from the program, written notice is required a minimum of 15 days prior to your next scheduled withdrawal.

**Penalties**  
An administrative fee of \$25.00 will be applied to your account for payments not cleared by your financial institution. In addition, a penalty of 1.25 per cent will be added to your account. Your account will be removed from the PTP Program and it will revert back to the regularly billed four instalment program if the payment is not replaced in the specified time.
