

For the first time in the history of the Regional Municipality of Halton, electors throughout the Region will vote and directly elect a person to fill the position of Regional Chair for the 2000-2003 term of Regional Council.

Candidates running for the office of Regional Chair will have their names on the ballots in each of the four area municipalities within the Regional Municipality of Halton, namely the City of Burlington, and the Towns of Oakville, Halton Hills and Milton.

The Municipal Elections Act, 1996 states that a candidate's election period begins on the date the candidate files a nomination paper. Contributions are considered to be any money, goods or services given to, or accepted by, or on behalf of the candidate and his/her campaign.

Nomination Procedure:

- Nominations using the prescribed form shall be filed at the Office of the Regional Clerk, Halton Regional Centre, 1151 Bronte Road, Oakville, in person by either the candidate or his/her agent;
 - during the hours of 8:30 a.m. to 4:30 p.m. on any given day from now until October 12, 2000 when the office is open to the public, or
 - during the hours of 9:00 a.m. to 5:00 p.m. on Nomination Day, Friday, October 13, 2000.
- The nomination shall be:
 - in the prescribed form available from the Regional Clerk or any of the Area Municipal Clerk's offices;
 - accompanied by a filing fee of \$100.00 payable in cash, certified cheque or money order, payable to The Regional Municipality of Halton, and,
 - accompanied by a consent to the nomination and a declaration of qualification, both in the prescribed form, signed by the person being nominated.
- The onus is on the person nominated for election to an office to file a bona fide nomination paper.
