## Water tank could be used as billboard to plug town

In Milton, new growth may not only pay for itself, but make an artistic statement, too.

A 1.5 million gallon aboveground water tank currently under construction on Steeles Avenue near Hwy. 401 may be used as a tower, said Councillor John wasn't sure the Region would be whopping billboard for the town, Milton's community services committee heard recently.

In the end that idea was supported by committee, including Mayor Gord Krantz.

"I think we're all saying the same thing. This is something new, something novel," he said. "We have an opportunity here. I'm prepared to go down (to the Region) and push for something that says Milton."

Committee chair Barry Lee seemed amused by the proceedings. "This item sure has inspired a lot of creativity around this table. But we should get on it.

"It's going up fairly quickly and (the Region) may have their own design ideas. I'm sure they do."
