



The first instalment of the final PTP billing was originally scheduled to be withdrawn from your bank account on June 01, 2000, with the last of the 5 (five) instalments being October 02, 2000. Due to delays in the billing process, the remaining 5 (five) PTP withdrawal dates have been changed

July 04, 2000 August 01, 2000 September 01, 2000 October 02, 2000 November 01, 2000 Please note that there will not be a withdrawal during the month of June as previously notified. A statement will be mailed to you shortly advising in writing of the withdrawal due dates and their respective amounts.
