## 2000 MUNICIPAL ELECTIONS NOTICE TO ELECTORS - NOMINATIONS

NOTICE IS HERBY GIVEN that every person who proposes to be a candidate for the 2000 - 2003 term of office must file a Nomination Paper with the Town Clerk and Returning Officer before incurring any expenses or collecting any money. The final day for filing a Nomination Paper is FRIDAY, OCTOBER 13<sup>TH</sup>, 2000 AT 5:00 p.m. Unless otherwise specified, Nomination Papers can be filed with the Town Clerk, Town of Milton.

Nominations, on the prescribed form, may be filed for the following Offices:

A THE TOWN OF MILTON FOR THE OFFICE OF:

Mayor (one to be elected) Local and Regional

Local and Regional Councillor, Wards 1 & 3;

Local and Regional Councillor, Wards 2 & 4 (two to be elected)

Local Councillors (eight to be elected) To be elected at large and serve as a member of Regional Council and Town Council.

To serve as a member of both the Regional Council and Town Council.

-One (1) Councillor to be elected from the combined Wards 1 (Trafalgar) and 3 (Nassagaweya) -One (1) Councillor to be elected from the combined Wards 2 and 4 (Urban Milton)

To serve as members of Town Council.
-Two (2) Councillors to be elected from Ward 1
(Trafalgar)

-Two (2) Councillors to be elected from Ward 2 (Urban Milton - west of Regional Road 25)
-Two (2) Councillors to be elected from Ward 3 (Nassagaweya)

-Two (2) Councillors to be elected from Ward 2 (Urban Milton - east of Regional Road 25)

B SCHOOL TRUSTEE - HALTON DISTRICT SCHOOL BOARD (English)

Trustee (one to be elected) One (1) to be elected at-large by Public School (English) Electors within the Town of Milton to serve as a Member of the Board of School Trustees for the Halton District School Board.

C SCHOOL TRUSTEE - HALTON DISTRICT SCHOOL BOARD (French) DISTRICT #58

Trustee (one to be elected) One (1) to be elected by Public School (French) Electors for District #58

 to serve as a member of the Board of School Trustees for the Halton District School Board (French) District #58.

D SCHOOL TRUSTEE - HALTON CATHOLIC DISTRICT SCHOOL BOARD (English)

Trustee (one to be elected) One (1) to be elected at-large by Catholic School (English) Electors within the Town of Mitlon to serve as a Member of the Board of School Trustees for the Halton Catholic District School Board.

E SCHOOL TRUSTEE - HALTON CATHOLIC DISTRICT SCHOOL BOARD (French) DISTRICT #64

Trustee (one to be elected) One (1) to be elected to represent Catholic School Electors within the Region of Halton to serve as a Member of the Board of School Trustees for the Halton Catholic District School Board. (French) District #64. (Please Contact the Clerks Department to ascertain where Nomination Papers for this position are to be filed).

F REGIONAL CHAIR

(one to be elected) (Regional Municipality of Halton) The Office of the Clerk of the Regional Municipality of Halton is responsible for accepting nominations for Halton Regional Chair. Please contact the Regional Clerk at 825-6000, Ext. 7237.

All the above offices are for a Three (3) Year Term. Candidates are required to submit Nominations on the prescribed form only. Such forms may be obtained from the Office of the Returning Officer, Clerks Department, Town of Milton, 43 Brown Street, during normal office hours (8:30 am to 4:30 pm)

NOTICE is also hereby given that The Municipal Elections Act provides that a Nomination Paper:

- a) shall state the name and address of the person nominated in such manner as will identify him/her, the office for which he/she is nominated, and the Ward (except those running at large) in which the candidate is proposing to be nominated.
- b) Be accompanied by a consent to the nomination and a declaration fo qualification, both in the prescribed form and signed by the person being nominated, and
- be accompanied by the prescribed nomination filing fee of \$100.00, payable only by cash, certified cheque or money order.

NOTICE is hereby given that the onus is on the person being nominated to file a bona fide Nomination Paper.

NOMINATIONS for elected office, duly certified by the Clerk, including name, address and office, will be posted at the Municipal Offices following Nomination Day (October 13th, 2000).
