NOTICE OF THE PASSING

OF ZONING BY-LAWS BY

THE CORPORATION OF THE CITY OF MISSISSAUGA

TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-laws 0545-2000, 0546-2000 and 0547-2000 on October 25, 2000 which repeal By-laws 0484-2000, 0485-2000 and 0486-2000 due to interpretative problems. By-laws 0484-2000, 0485-2000 and 0486-2000 were advertised previously on October

AND TAKE NOTICE that the Council of the Corporation of the City of Mississauga passed By-laws 0548-2000, 0549-2000 and 0549-2000 on the 25th day of October, 2000, under Section 34 of the Planning Act R.S.O., 1990, c.P.13, as amended. These three By-laws replace the repealed By-laws 0484-2000, 0485-2000 and 0486-2000.

AND TAKE NOTICE that any person or agency may appeal to the Ontario Municipal Board in respect of the Bylaws by filing with the Clerk of the City of Mississauga not later than the 28th day of November, 2000, a notice of appeal setting out the objection to the By-law and the reasons in support of the objection, together with a cheque in the amount of \$125.00 payable to the Minister of Finance for each of the By-laws.

Only individuals, corporations and public bodies may appeal a Zoning By-law to the Ontario Municipal Board. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

Explanation of the purpose and effect of the by-laws:

By-law 0548-2000 to amend Zoning By-law (former Town of Mississauga), Byto amend Zoning By-law of Streetsville) and 0550-2000 to amend Zoning By-law Port Town buildings play on residential lots used for a detached, semi-detached or street row dwellings, by:

- building, accessory height of accessory building other than an attached private garage, flat roof of a private garage and play detached equipment;

These replacement By-laws differ from their predecessors by including new or additional provisions that, among other things:

- restrict the size of an attached private garage to 75 m²; and
- attached private continue to allow an garage to project beyond the front wall of a dwelling, unless otherwise prohibited;
