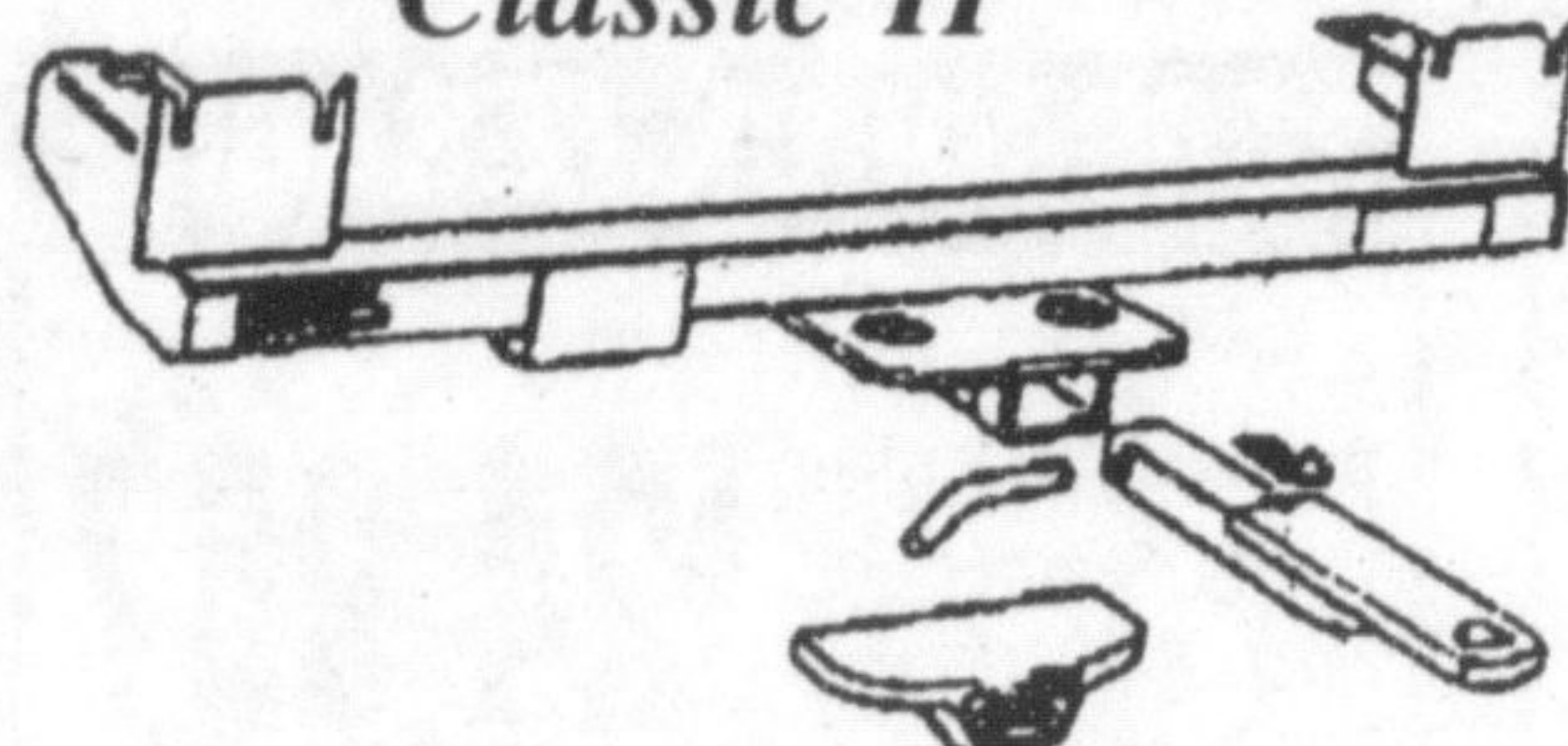

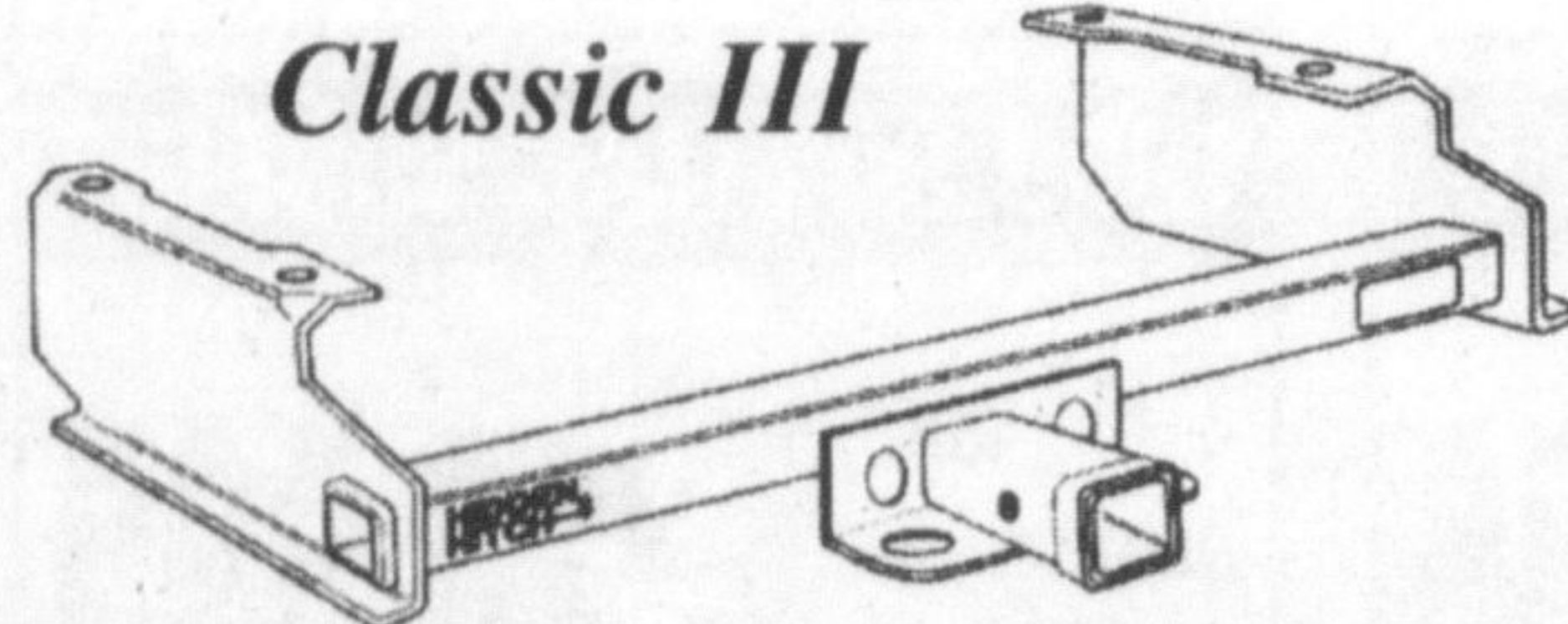

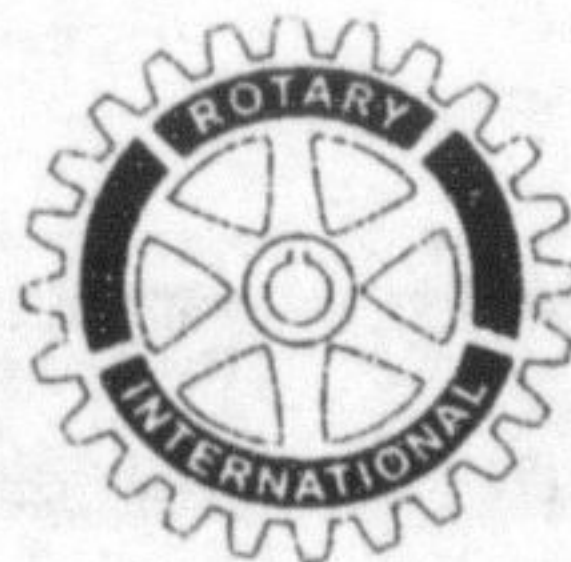

THE SCHOLARSHIP

SELECTION CRITERIA

- The candidate must be a resident of Milton
- The candidate must be currently attending a Milton Secondary School

- Candidates should list organizations in which they have participated and indicate positions held and contributions made
- The student should be able to articulate some future careers goals and objectives

APPLICATION PROCESS

Students from the high schools in Milton are to submit an application consisting of:

- A cover letter
- An essay of 100 words or less (related to the selection criteria)
- A resume

A short list of applicants will be selected for an interview to determine the scholarship winner.

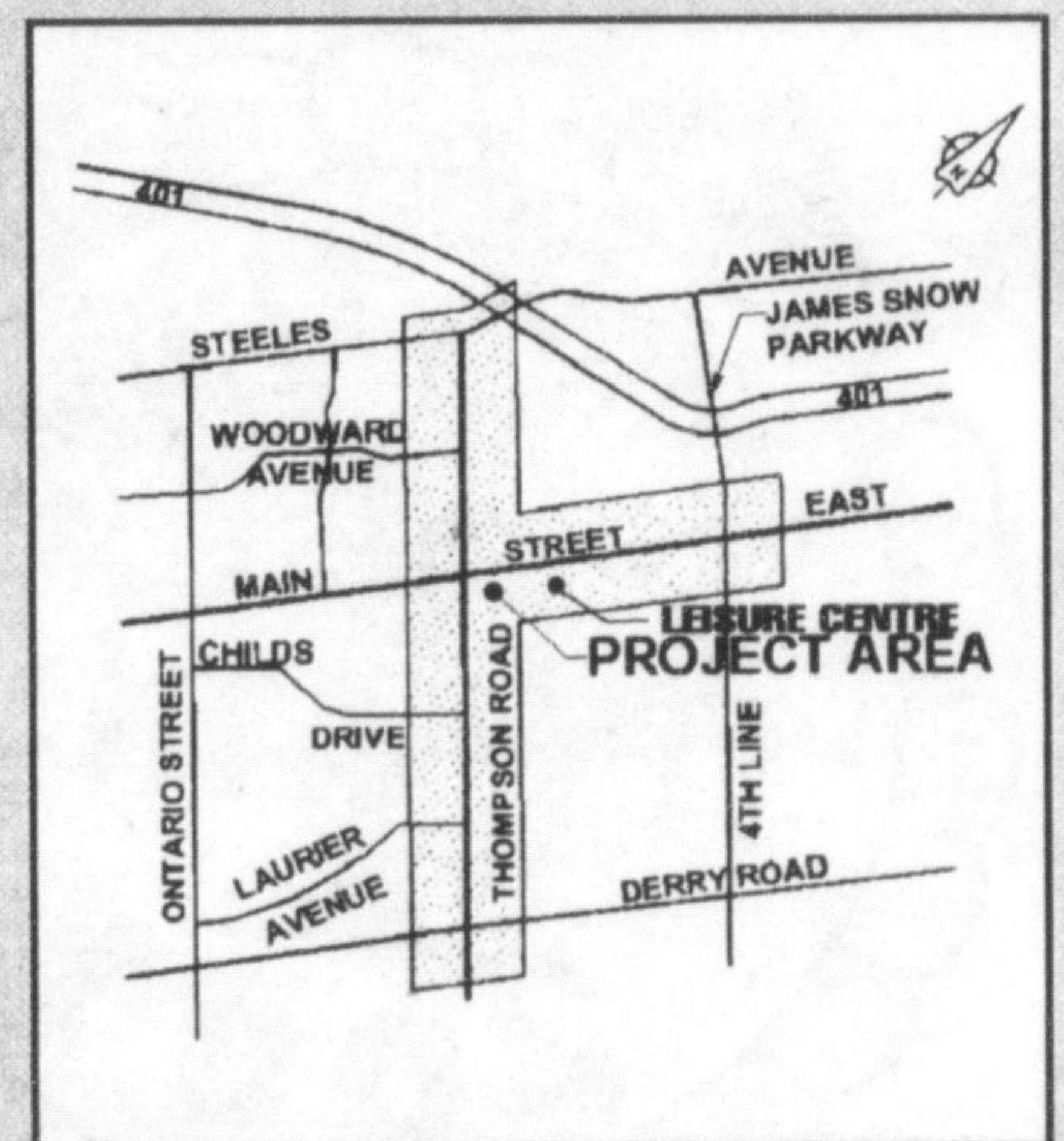

TOWN OF MILTON Class Environmental Assessment NOTICE OF COMPLETION OF ENVIRONMENTAL STUDY REPORT MAIN STREET EAST AND THOMPSON ROAD IMPROVEMENTS

The recommended solution to address traffic, pedestrian, safety and maintenance needs on Main Street East between Thompson Road and James Snow Parkway and Thompson Road between Derry Road and Steeles Avenue in the Town of Milton is to upgrade and urbanize/widen the roadways as well as to provide combined sidewalks/bike paths. Construction is scheduled for completion in 2001 for Main Street East and 2002/2003 for Thompson Road and will result in four lane roadways for the road sections under study.

This project is being conducted in accordance with the requirements outlined in the Municipal Engineers Association Class Environmental Assessment for Municipal Road Projects (Class EA) document. An Environmental Study Report (ESR) has been completed and by this, notice is being placed in the public record for review. Subject to comments received as a result of this Notice and the receipt of necessary approvals, the Town of Milton, intends to proceed with design and construction of the project.



Interested persons may provide written comment to the Town within 30 calendar days from the date of this Notice. Correspondence should be directed to Mr. P. Antoniow at the Town of Milton, Community Services Department. If you feel, after consulting with Town staff, that serious environmental concerns remain unresolved, written requests for a "bump up" review of this project to an individual environmental assessment may be made to the Minister of Environment.

"Bump up" requests must be received by the Minister at the address below within 30 calendar days of the date of this Notice. A copy of the "bump up" request shall be sent to the Town's Director of Community Services. If there is no "bump up" requests received by April 4, 2001, the proposed improvements to Main Street East and Thompson Road will proceed to design and construction as outlined in the ESR.
