Man sent to jail for WSIB fraud

A Milton man has been found guilty of two counts of fraud, one count of forgery and one count of uttering a forged document following an investigation by the Workplace Safety and Insurance Board (WSIB).

Dennis Samuel Rowley was sentenced in Ontario Court March 5 to 16 months in jail and ordered to pay \$86,000 in restitution to the WSIB.

Court heard Mr. Rowley received benefits from the WSIB while failing to declare he was employed. He also received benefits that were based on false documents submitted to the

WSIB. He claimed WSIB benefits, travel expenses and retraining expenses to which he wasn't entitled, totalling in excess of \$86,000.

"Anyone who attempts to claim benefits that they're not entitled is undermining the effective operation of Ontario's workplace safety and insurance plan, said Linda Lamoureux, the WSIB's director of special investigations.

"By prosecuting these offenses, the WSIB is helping to ensure a fair workplace insurance system and safe and healthy workplaces for all Ontarians."

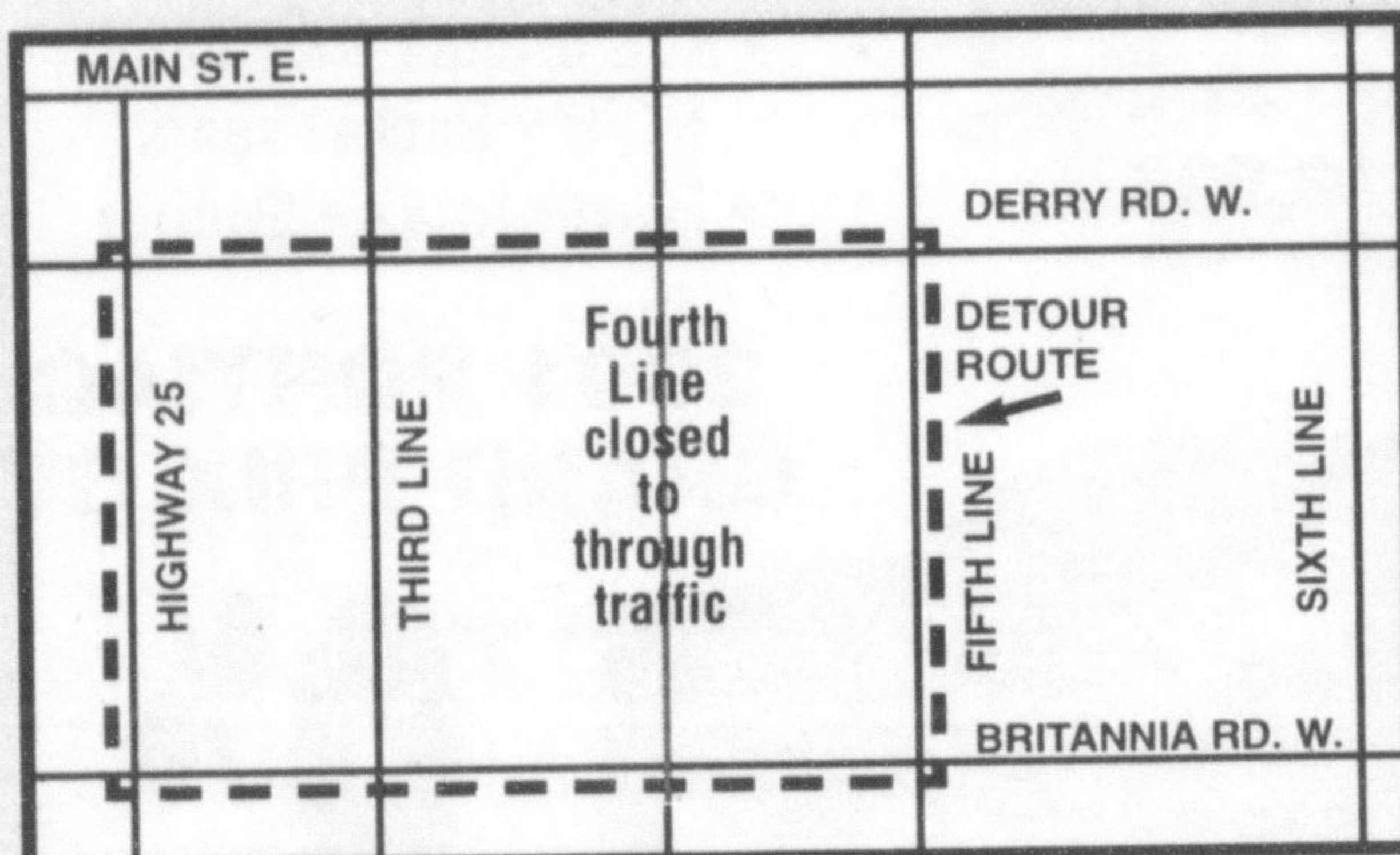

Notice of Public Information Centre Charles Street - Lydia Street to Commercial Street Traffic Study

The Town of Milton has approved the reconstruction of Charles Street between Commercial Street and Pine Street. During the design stage of the project it has become evident the section of Charles Street between Commercial Street and Lydia Street would not support two way traffic. As a result, the Town is considering a one way designation of this section of roadway. The Town has completed a traffic study to determine the traffic impacts on adjacent streets with a one way designation.
