

Six different Christian denominations will take part in one large Good Friday service

Local history will be made when denominations of the Christian faith will gather together for one large Good Friday service at Holy Rosary Catholic Church.

"A few months ago the Milton Ministerial Association gathered together and we were chatting about doing something for the community," said Rev. Rod Lewis of Knox Presbyterian Church.

"We said, why don't we celebrate Good Friday together? The central belief surrounding the different denominations is the cross and the resurrection of Jesus so we thought we could do this."

The 10 churches involved with the service will abandon their regularly scheduled services and gather at Holy Rosary for a 10 a.m. service.

"We are expecting hundreds of people, and Holy Rosary is the largest sanctuary in town, so that's why the service is being held there," Rev. Lewis said.

"I'm really excited about this. This is the first time a significant gathering of the denominations will take place."

Churches involved in the combined service include Anglican, Presbyterian, Baptist, Alliance, Salvation Army and Catholic, he said.

"Some churches are staying with their own plans," Rev. Lewis said.

"Some had their services well in hand already and it's difficult to abort that."

Mixed feelings

Right now the churches are in the middle of announcing and promoting the service, he said.

"The folk I've talked to said they think this is great and I hope that's the general feeling among the congregations. Some folk don't necessarily agree (with the mixed service) but that's to be expected."

Rev. Lewis said the service will be their way of demonstrating the "larger body of Christ."

"We're all part of a common faith and heritage. We want to express that in a meaningful way."

Rev. Lewis stressed the service was arranged by the Milton Ministerial Association and it's not a Holy Rosary service.

"Various clergy of the churches will be part of the service," he said.

"Everyone will participate. It's not a sermon, there won't be any preaching. It's a service of praise, prayer and reflection."

BOARD OF MANAGEMENT FOR THE DOWNTOWN BUSINESS IMPROVEMENT AREA (DBIA)


