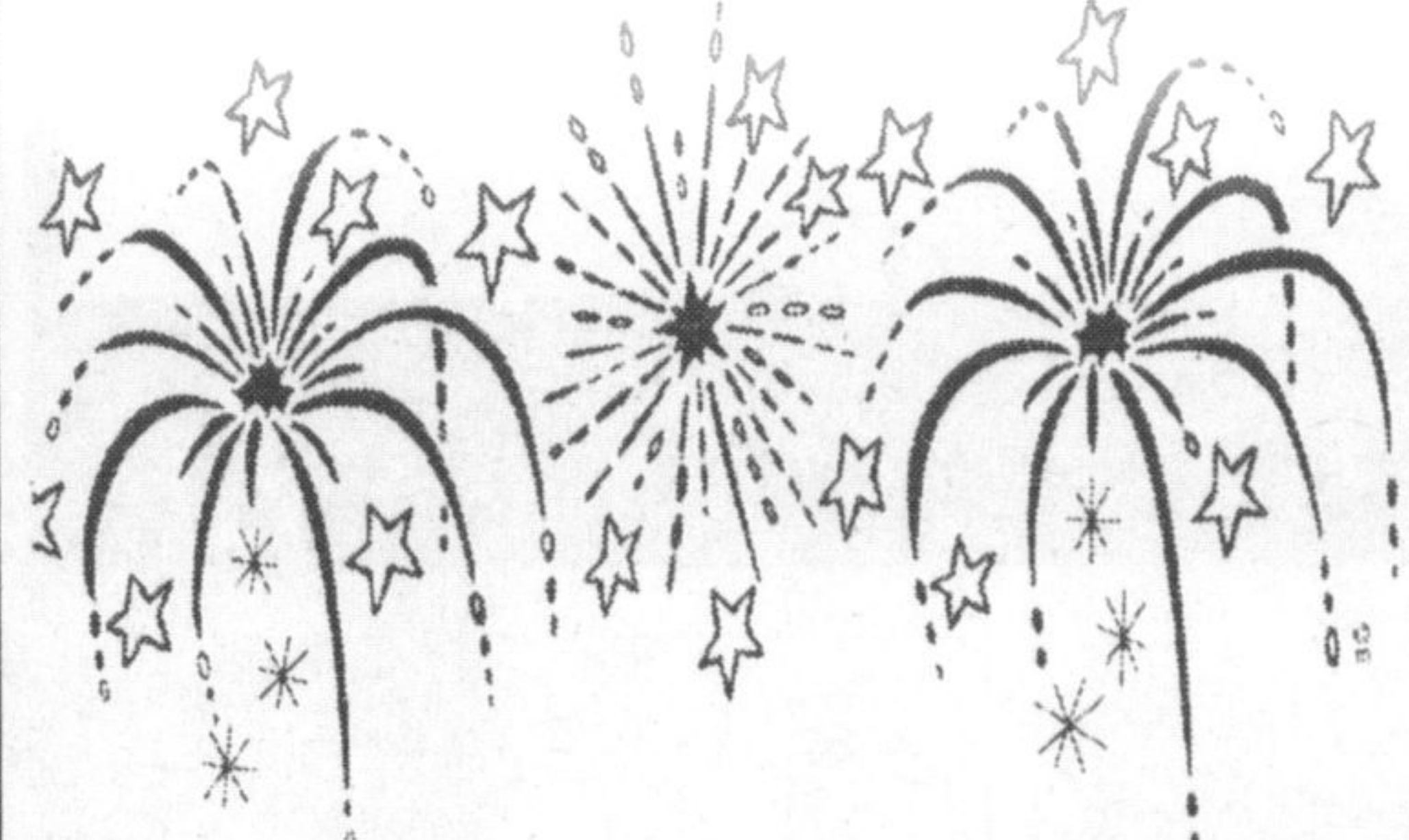

Driver injured when her van crashes into dealership

Luckily, no one was in car lot

A 44-year-old Milton woman was sent to hospital with non-life threatening injuries following a single car crash at Richardson Chev-Olds at Derry Road and Ontario Street Saturday.

At about 9:40 p.m., a 2000

Windstar van travelling north-bound on Hwy. 25 veered into the parking lot of the dealership, damaging a Camero SS and three ST extended cab pick-up trucks.

Two of the trucks were damaged beyond repair. The loss had yet to be estimated at press time.

Fire and ambulance workers responded to the crash and transported the driver to Milton District

Hospital.

"My only concern is that she's (driver) all right," said Brent Richardson, general manager of the dealership. "Cars can be replaced."

Although a cause for the crash has yet to be determined, police are checking the van for possible safety flaws.

The investigation continues.
