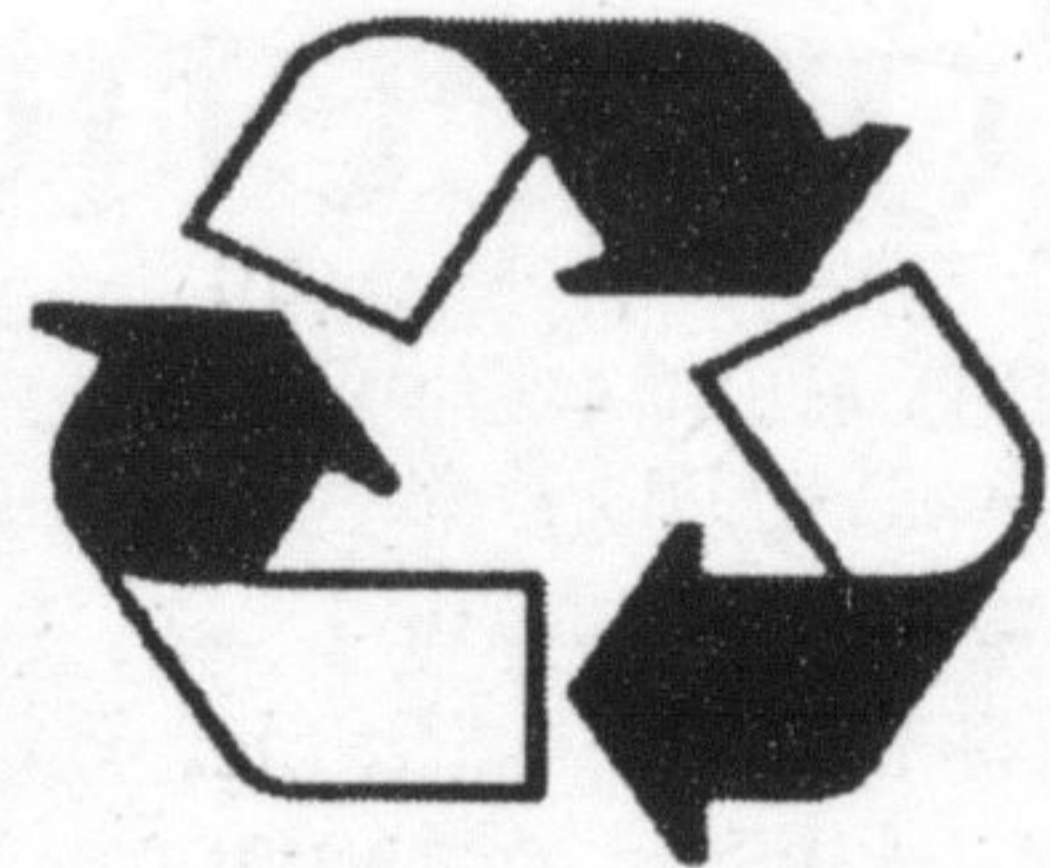
I don't get it. And just who are they talking to at 3 in the morning?

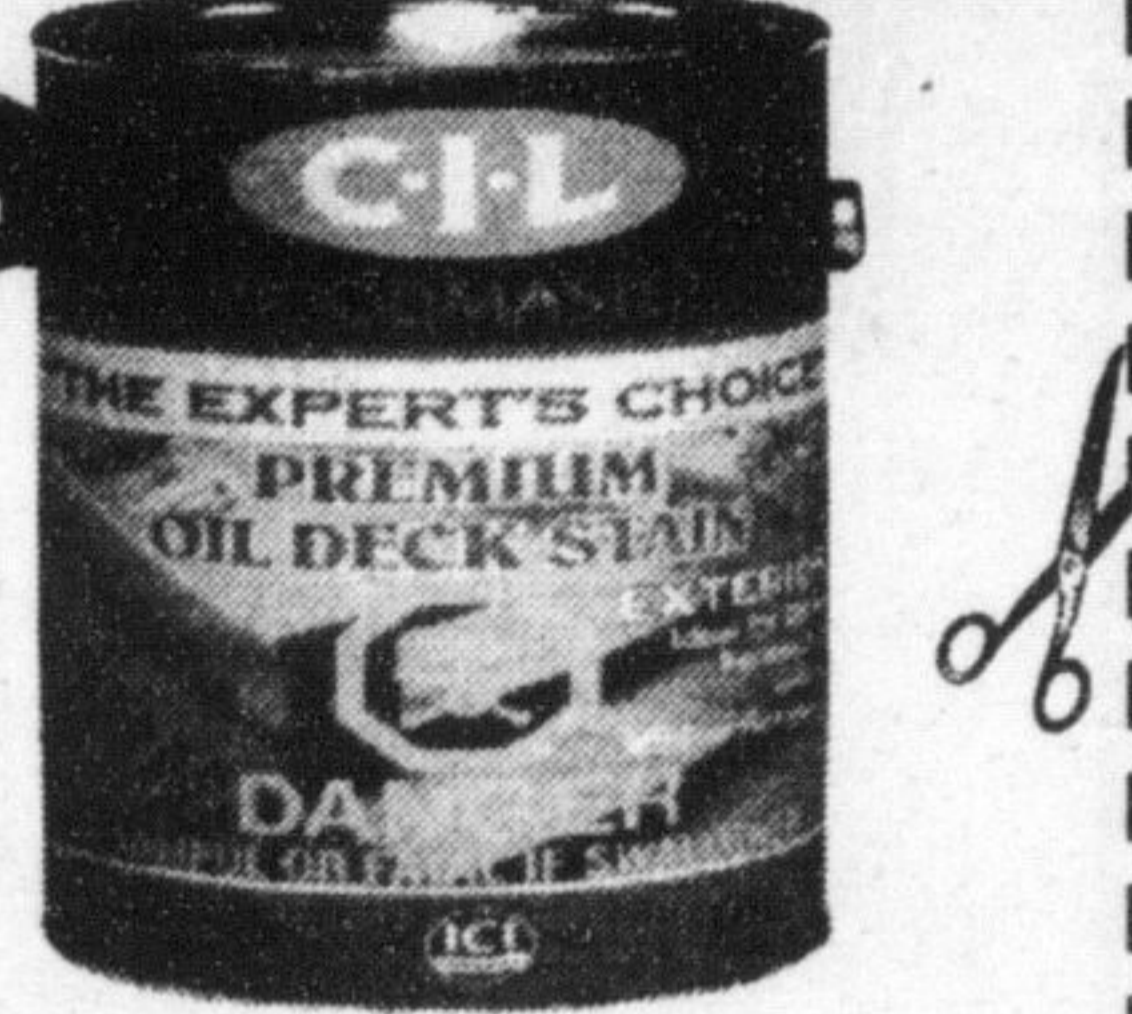

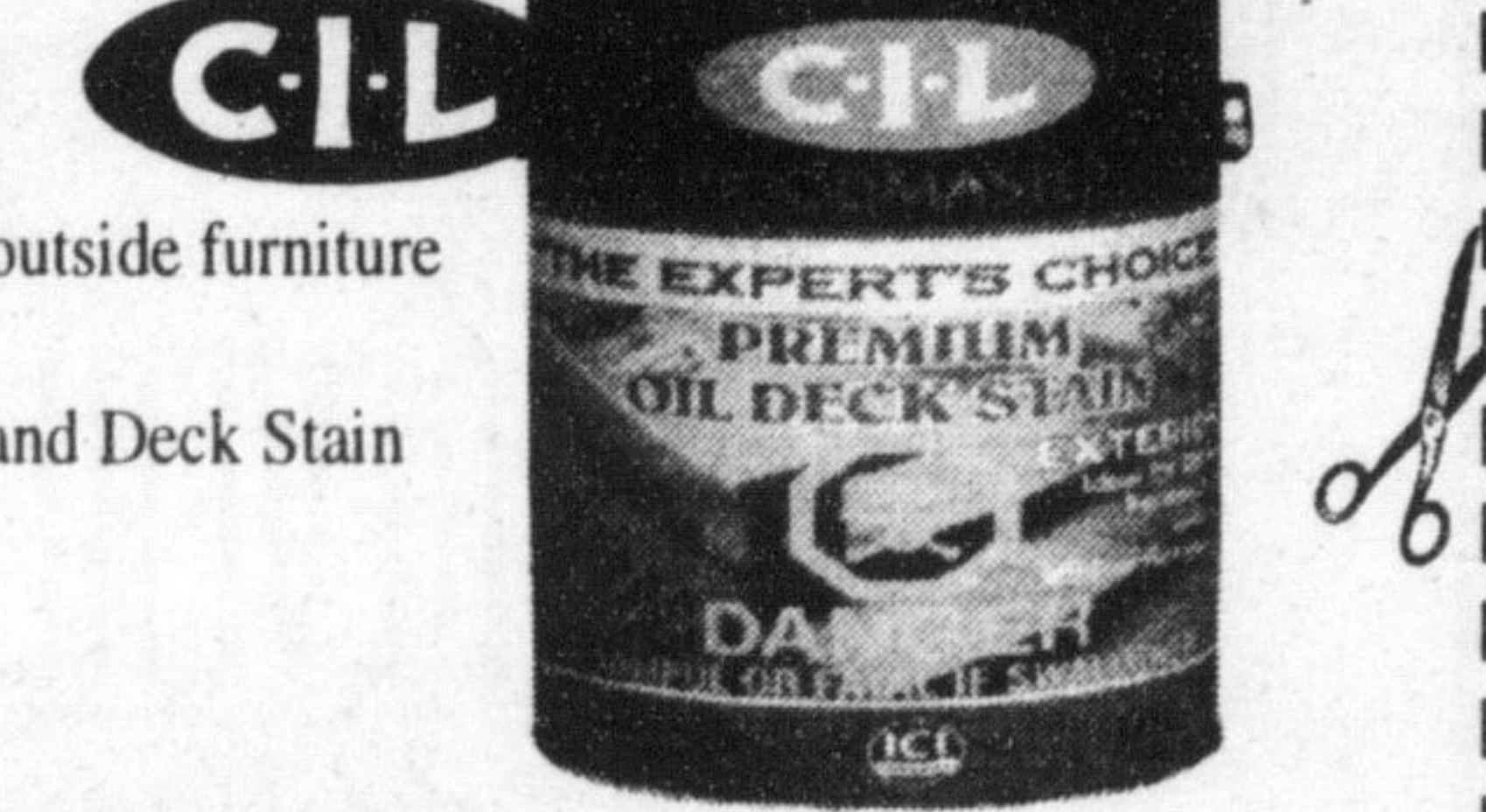

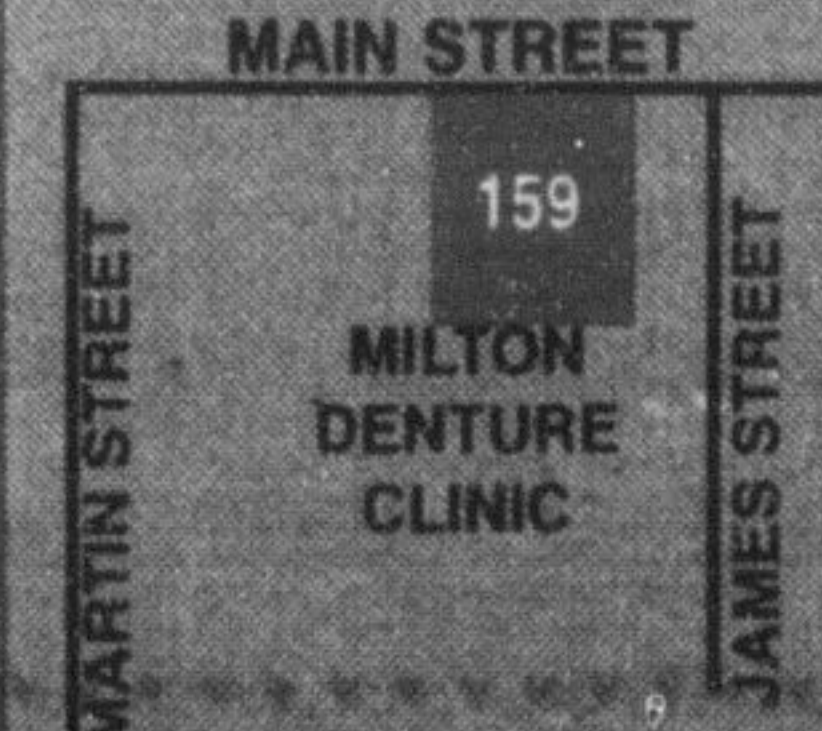
