Changes could boost business: Chudleigh

After months of discussion with representatives of the chemical and construction sector, Halton MPP Ted Chudleigh believes changes are needed to keep Ontario businesses competitive.

In his report 'Keeping Ontario Industries Competitive in the Global Market', released last Tuesday, Mr. Chudleigh set out 23 recommendations to boost the standing of Ontario businesses.

"Ontario must be competitive to maintain a strong economy," said Mr. Chudleigh, parliamentary assistant to Bob Runciman, minister of economic development and trade. "I believe the recommendations for these consultations and discussions with players in a number of Ontario's key sectors will help us to raise our level of competitiveness in the global marketplace."

Reacting to the report, Mr. Runciman also announced last Tuesday the Province is prepared to move forward with several of the recommendations, including the establishment of a construction industry advisory council, a \$100,000 investment to support the formation of a Toronto angel

group (an informal group of potential investors seeking opportunity) to screen business opportunities, and the hosting of an angel investment forum in April.

"The Ontario government constantly seeks new ways to ensure our businesses can attract, maintain and retain investments and jobs," the minister said.

"By moving forward immediately on some key recommendations, our government is working to ensure our province maintains a vibrant capital market — a market that is essential to Ontario's economic expansion and international competitiveness."

Added Mr. Chudleigh: "Perhaps the most important recommendation from Halton's standpoint is a call to reduce or eliminate tax on capital gains arising from investments in companies with assets under \$5 million.

"I've also indicated that Ontario should press the federal government to match this provision. The result would be a competitive position for investors who might otherwise consider investing in American companies.

Reconstruction of Main Street (Commercial Street to James Street)

The Town of Milton is currently planning the reconstruction of Main Street between Commercial Street and James Street. The proposed work will be done in co-ordination with the Region of Halton and includes the construction of new water services, wastewater mains, storm sewers, concrete curbs and sidewalks, on-street parking, streetlights, landscaping and asphalt road surface.

Preliminary design work for this project began in 2000 when the Central Business District Streetscape Study was initiated. This recently completed study provides guidance for the reconstruction of Main Street from Thompson Road to Bronte Street including its general appearance. Detailed design for the reconstruction of the road between Commercial Street and James Street is underway. Construction will begin in March 2002 and most work is expected to be complete by the end of May 2002. During construction, access to all businesses and residences within the project limits will be available.
