Derry Road (Regional Road 7) Improvements Fifth Line to Ninth Line Class Environmental Assessment Study

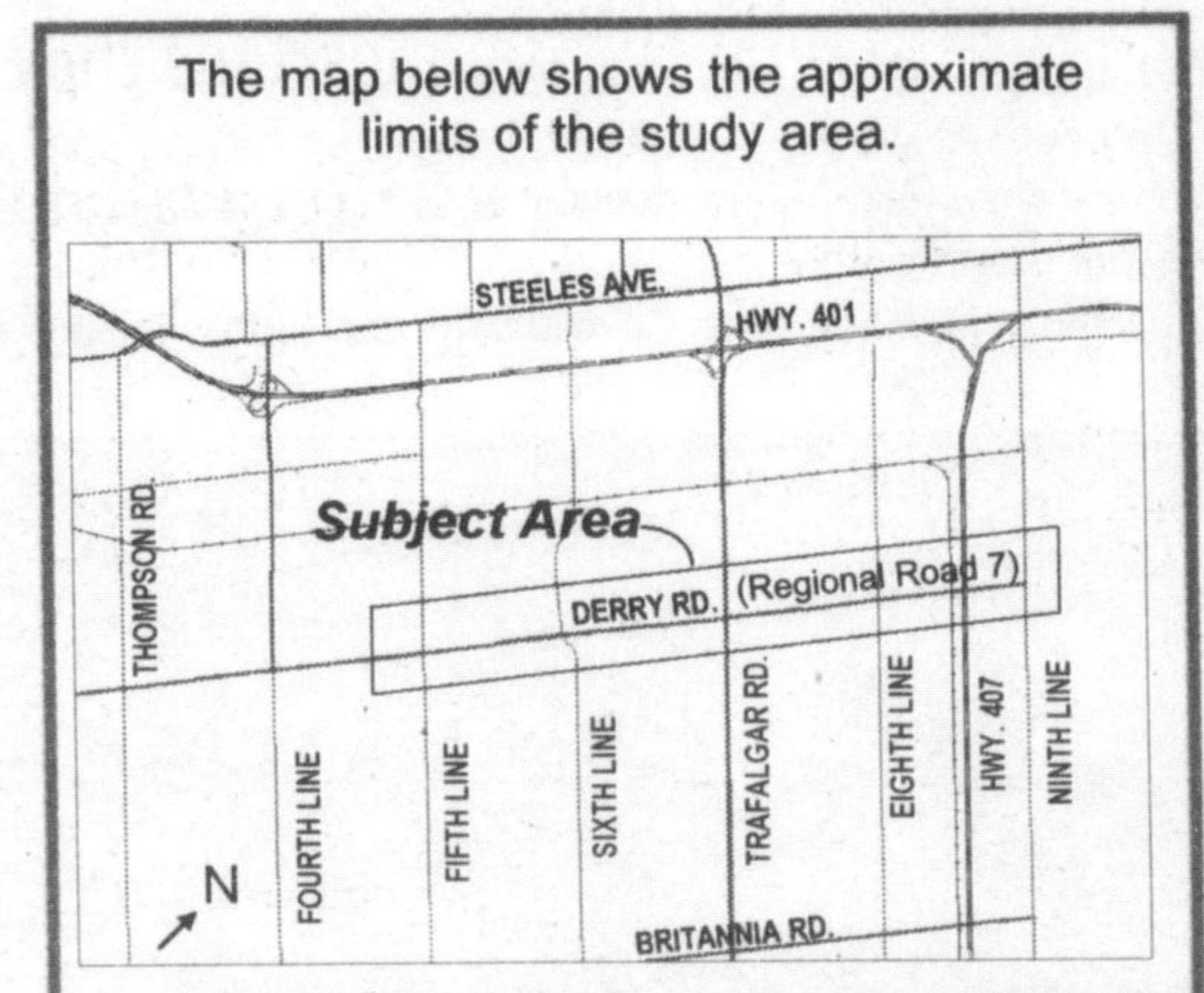
The Regional Municipality of Halton has initiated a Class Environmental Assessment to consider a wide range of options to satisfy future travel demands on Derry Road from approximately 150m east of Fifth Line to Ninth Line (see map below). In order to best address existing and future operational deficiencies associated with this segment of Derry Road, a number of road improvement alternatives will be examined as part of the study including widening, new road alignments and improvements to intersections, among others.

The study will define the problem and consider, evaluate and detail alternative solutions and design concepts. The study is being conducted in compliance with Schedule C of the Municipal Class Environmental Assessment (June 2000), which is approved under the Ontario Environmental Assessment Act.

A Public Information Centre (PIC) is planned to provide further information to the public and interested stakeholders and to receive input and feedback on the study to date. The PIC is scheduled for:
