

HHS Launches Public Opinion Survey



The random telephone survey will measure the attitudes and opinions of residents as they relate to the quality of care and services provided at Milton District Hospital and Oakville-Trafalgar Memorial Hospital.

The survey is part of Halton Healthcare's commitment to continuously improve the quality of care and services provided to the residents of Oakville and Milton.

The survey will be conducted by Pollara, a national public opinion research firm. Random calls will be made to a total of 600 households. Each call will take approximately 15 minutes to complete.



DID YOU KNOW...

The Charitable donation tax credit is calculated as 16 percent on the first \$200 of eligible donations, plus 29 per cent of the amount in excess of \$200.

A credit can be claimed for donations made in the current and/or the preceding five years (if not already claimed), based on an annual limit - generally 75 per cent of net income. In the taxpayer's year of death and for the preceding year however, that limit increases to 100 percent.

You may also claim donations made by your spouse or common-law partner. To maximize the charitable donation credit, consider combining both your donations if they total in excess of \$200. If not, it may be best to defer claiming these deductions, subject to the five-year carry-forward limitation, to get above the \$200.




