# Real Desire appears ready to make return

### Top pacer delivers strong qualifying mile

Real Desire, last season's Breeders Crown and Meadowlands Pace champion, is one step closer to making his return to the races after a stellar qualifying mile in less than stellar conditions Tuesday morning at Campbellville's Mohawk Racetrack.

On a rain-soaked surface in which the Ontario Racing Commission judges allowed two extra seconds for the track condition, the four-year-old son of Life Sign floated out of the starting gate second, and then eased to the front for trainer Blair Burgess long before the half in

Real Desire's pace then quickened as he spun off a back half of :56.1 to leave the rest of his rivals 26 lengths behind by the time he tripped the teletimer in 1:55.1.

"He seemed good. He was all by himself and it was just like a training mile for him," said Burgess, who surprised some

backstretch followers by qualifying in the

"He's definitely (qualifying) again. The reason I went today was that it gives me the option of going again next Tuesday or taking the extra three days and going on the Friday."

After a number of sensational battles with arch-rival Bettors Delight through the grueling three-year-old events last season, the winter of rest has done wonders physically for Real Desire.

"He's definitely gained a lot of weight," said Burgess. "He's longer and taller."

Owned by Campbellville's Robert Burgess and Miltonian Karin Olsson Burgess — along with American partners Brittany Farms and Perretti Farms — Real Desire will enter his four-year-old campaign with career earnings of \$2,100,024.

Pepi Lavec survived a tough trip to capture the second of three Gold Eliminations by three quarters of a length in 2:01.2.


