search of a better life.

"He was the kindest person I had ever met. He was an innocent victim of a tragic accident that left him to die alone on the road. The fact Mr. Carroll did not stop was callous and cowardly. I will miss him every moment for the rest of my life."

The Wierzbicki's youngest son, Daniel, 5, wasn't in court.

Following the victim impact statements, Mr. Carroll read a letter of apology to the victim's family.

"I've been waiting for this moment for 10 months. There is absolutely no excuse for my actions. I should have stopped the car and assisted the man. I accept full responsibility for my actions. I never thought I would be capable of such a cowardly and despicable act. I hope some day I will be able to face this tragedy like a man. Although I don't know this man, he will always be in my

thoughts." During final submissions, assistant Crown attorney Mary Ward told the court she's seeking a jail term of nine to 15 months plus a

five-year driving ban. Defence lawyer Fred Fedorosen argued his client should receive

a conditional sentence to be served in the community. Mr. Carroll pleaded guilty in March to careless driving causing

death and failing to remain at the scene of an accident. He was travelling on Tremaine Road, just north of Derry Road, at about noon August 14 when he struck Mr. Wierzbicki, 41. He

was pronounced dead at the scene. At the prompting of his ex-wife, Mr. Carroll turned himself into Halton Regional Police two days after the accident and confessed to the hit-and-run.

Sentencing is scheduled for August 26 before Justice Harry Edmonstone in Oakville court.

## Trustees considered having deficit budget

Strategic Plan and construct needed schools and, potentially, the ability to open existing schools in the fall of 2002, be it resolved that the HDSB, with great reluctance, approve the 2002-03 budg-

As well, the board's budget directive will ask Ontario Education Minister Elizabeth Witmer to send a representative to meet with Halton Education Director Dusty Papke "to examine the HDSB budget in detail and provide solutions to the financial shortfalls that are inherent in this budget."

Trustees will also request that one-time funding be made available to the board from the government's contingency fund, which, trustees say, was created by budget surpluses of \$1 billion per year for the provincial budgets of 2001-02 and 2002-2003.

Several Halton trustees wanted to actually submit a deficit budget. It has been done by the Ottawa-Carleton school board while the Hamilton-Wentworth public board approved a deficit budget Monday. The Toronto public board is also considering a deficit budget. Ms Witmer has appointed a ministry official to look into the Ottawa-Carleton case.

Under provincial legislation, trustees can be fined and/or removed from office for passing budget deficits with board operations potentially taken on by the ministry.

"This board is just the right size to be taken over," Milton Trustee Erica Andrew told her colleagues prior to the passing of the balanced budget. "I don't think we can afford to call the government's bluff."




