Man charged with harassment following complaint from boy

Suspect was part-time instructor at Oakville martial arts school during alleged incidents

A part-time instructor at an Oakville martial arts school has been charged with criminal harassment following a complaint from a 13-year-old male student.

According to Halton Regional Police's Child and Sexual Assault Bureau (CASA), the instructor, who lives in Milton, was arrested October 16.

His arrest culminated a two-week inves-

tigation initiated by a complaint from the student.

The alleged incidents — which were reported by the boy to his parents, who in turn called police - involved unwanted communication and attempts by the instructor to have the youth meet him at another location.

In addition, police said the instructor was

observed by the boy's father driving by his son's home on several occasions in early October.

The police investigation included interviews with other students at the martial arts school where the man is no longer teach-

The name of the school has not been released by police to protect the identity of the student,

A 26-year-old Dolby Crescent man has been charged with criminal harassment and will appear in Oakville court Tuesday.

Man is robbed at Milton Mall; police looking for three suspects

A 45-year-old man was grabbed from behind and pinned against the wall by three men during a robbery in the washroom at Milton Mall last Friday.

The man was shopping at the mall at 7:30 p.m. and made a stop in the washroom by the Food Court when he was attacked by three unknown males. The three suspects took a large quantity of cash from the victim before fleeing the area,

police said.

The victim wasn't injured.

The first suspect is described as an 18year-old white male with a large build, five-foot-seven, 150 pounds, with short blond hair and a goatee. He was wearing blue jeans and a baggy white sweater.

The second suspect is described as a white male between 17 and 18 years of age, five-foot-six with a medium build. He

was wearing a black jacket.

The third suspect is described as a white male between 17 and 18 years of age, fivefoot-10 with a thin build. He was wearing a yellow sweater, brown pants and a blue baseball hat.

REGARDING PROPOSED AMENDMENTS TO THE OFFICIAL PLAN AND ZONING BY-LAW OF THE TOWN OF MILTON REGARDING ADULT ENTERTAINMENT

TAKE NOTICE THAT the Planning and Administration Standing Department, 155 King Street, Milton. Committee of the Town of Milton will hold a Public Meeting on:

Monday, November 18, 2002

to receive information and public input on proposed amendments to the Town of Milton Official Plan and Zoning By-law pursuant to Sections 17 and 34 of the Planning Act, as amended.

These are comprehensive amendments and affect all lands within the corporate boundaries of the Town of Milton.

The Town of Milton is proposing to amend the Official Plan and Zoning By-law to clarify the Town's intent with respect to Adult Entertainment Uses, including Adult Video and/or Specialty Stores and Body Rub Parlours.

The purpose and effect of the Official Plan and Zoning Amendments is to permit these uses on lands that are designated Industrial and located north of Highway 401. In addition, distance separation from residential and other sensitive land uses of 500 metres, arterial roads and highways of 100 metres are proposed. Other criteria include restricting one adult entertainment use per lot and restricting the percentage of floor area of a multi unit building to be used for an Adult Entertainment Use to 15% of the total floor area.

The proposed amendments will be available with the Initial Report scheduled for the November 18th meeting. This report will be available for Milton ON L9T 5H2 review after 3 p.m. on November 14th in the Planning and Development

Any interested person may make a written submission, prior to the public meeting, and should direct the submission to the Director of Planning and Development.

ANY PERSON MAY attend the public meeting to obtain information and make a verbal presentation and/or written submission, to identify issues of concern and/or express views in support of, or in opposition to, the proposed amendments.

The public meeting is an information meeting and a staff recommendation on whether to approve or refuse the application will not be made at this public meeting. A decision on the amendments is expected on November 25th, when a Technical Report with recommendations will be brought forward for consideration by Milton Council.

IT SHOULD BE NOTED that if a person or public body that files an appeal of a decision of the Town of Milton in respect of the proposed official plan amendment or by-law does not make a verbal presentation at the public meeting or make a written submission to the Town of Milton before the proposed amendments are adopted, the Ontario Municipal Board may dismiss the appeal.
