

The Town is a step closer to allowing the most environmentally sustainable community in Canada to be developed in Milton.

Members of the administration and planning committee threw their unanimous support behind a series of recommendations designed to promote the establishment of the Eco-Tech Village project Monday.

"I am excited by the potential of this project," said Councillor Brian Penman.

"Whatever shape, form it (project) takes, ultimately, the greater task will be to try to use that as a benchmark for whatever growth we experience."

The Eco-Tech Village pilot project is an effort by the Town and other partners (Halton Region, Milton Hydro, Rogers, Mattamy Homes and the Province of

Ontario) to reduce obstacles to creating a marketable, environmentally sustainable residential community

"The Town of Milton is going to be experiencing a very high rate of growth over the next while. The principal behind the Eco-Tech Village is to reduce the ecological footprint (created by growth)," Ruth Victor, a planning consultant hired by the Town, explained to the committee.

Among the committee-approved recommendations — derived from a series of five workshops attended by the Town and its partners — are the active promotion of changes to the building code to permit the collection and re-use of rainwater for non-potable purposes, that pesticides and herbicides be restricted on private and public lands and to seek federal funding for alternative energy demonstration projects.

Several recommendations more

directly involved the Town and its

The inclusion of policy provisions to permit live/work areas adjacent to transit ways, preservation/re-creation of natural systems in public parks and the reduction or prohibition of two car garages to promote use of transit were accepted in the recommendations.

If ultimately approved, the recommendations will be given consideration by the Sherwood Survey Secondary Plan Project Team in the development of the draft secondary plan for the urban Milton expansion, phase two.

The Town wouldn't be directly involved in the building of the Eco-Tech Village, but is involved in lifting possible policy barriers to its creation by private developers.

Milton council has yet to formally address the issue, but is expected to give it consideration Monday.
