

### NOTICE OF STUDY COMPLETION

Guelph Line (Regional Road 1) Improvements. Town of Milton Class Environmental Assessment Study

The Regional Municipality of Halton has undertaken a Class Environmental Assessment (EA) to consider a wide range inadequacies and drainage deficiencies 20 SIDE RD (R.R. 34) on Guelph Line (Regional Road 1) from 15 Side Road north to 20 Side Road (Regional Road 34). To best address the structural/drainage deficiencies associated with this segment of Guelph Line, a number of road improvement alternatives were examined as part of the study including complete reconstruction (2 lane), an improved vertical alignment, geometric and drainage improvements and improvements to the intersection of



Guelph Line (RR1) and 20 Side Road (RR34), among other alternatives.

The study was conducted in compliance with Schedule C of the Municipal Engineers Association Municipal Class Environmental Assessment (June 2000). In accordance with the Municipal Class EA, an Environmental Study Report (ESR) was prepared to document the planning and decision-making processes followed. As documented therein, the Preliminary Preferred Design calls for the reconstruction (2 lane) of the approximately 3.1 km segment of Guelph Line between 15 Side Road to 20 Side Road (RR 34).

By this Notice, the ESR is being placed on the public record for a 30-day review period in accordance with the requirements of the Municipal Class EA. Subject to comments received as a result of this Notice, the Region intends to proceed with detailed design and construction of the section of Guelph Line.



### NOTICE OF STUDY COMPLETION

Trafalgar Road (Regional Road 3) Improvements Town of Milton Class Environmental Assessment Study

The Regional Municipality of Halton has completed a Class Environmental Assessment (EA) to consider a wide range of options to satisfy travel demand on Trafalgar Road (Regional Road 3) from Britannia Road north to the south ramp of Highway 401. To best address the operational deficiencies that are currently associated with this segment of Trafalgar Road, a number of road improvement alternatives were examined as part of the study including widening of the roadway, new road alignments, railway

intersections and other alternatives.



The study was conducted in compliance with Schedule C of the Municipal Engineers Association Municipal Class Environmental Assessment (June 2000). In accordance with the Municipal Class EA, an Environmental Study Report (ESR) was prepared to document the planning and decision-making processes followed. As documented therein, the Preliminary Preferred Design calls for the widening of the approximately 5.1 km segment of Trafalgar Road(RR3) between Britannia Road(RR6) and the south ramp of Highway 401 from two to four lanes (five lanes in some sections) and construction of an overpass at the existing Canadian Pacific Rail crossing.

By this Notice, the ESR is being placed on the public record for a 30-day review period in accordance with the requirements of the Municipal Class EA. Subject to comments that were received in response to this Notice, the Region intends to proceed with detailed design and construction of the section of Trafalgar Road(RR3) between Britannia Road(RR25) and the south ramp of Highway 401.
