Salvation Army in dire need of more volunteers

Holiday season brings increased demand for help

As the holiday season quickly approaches, the Salvation Army faces it with a good news/bad news situation.

The good news being that the number of families needing assistance has declined from last years, while the bad news is that more volunteers are desperately needed to run the kettles at various locations through-

out Milton and Campbellville. With some luck, this Christmas season will be a joyous one.

The Salvation Army office in Milton opened approximately 14 years ago and, although open all year round, the holiday season is the busiest.

"Last year we helped 155 local families with the Toy Shop and food hampers," said Laurie Good, Family Services worker at the Salvation Army.

"This year we believe our total will be closer to 100, unless we get a lot of emergency families really close to Christmas."

Last year the numbers tended to be higher due to the repercussions of the terrorist attacks on September 11. Many people were laid-off from their jobs and they needed help making Christmas special for their families.

The Salvation Army was there to lend a hand.

The Toy Shop has toys and gifts for children of all ages, but more gifts are needed for the older kids and teenagers.

Items such as curling irons, small radios, compact discs, and clock radios are in high demand.

"The older children tend to be forgotten when people make donations," said Ms Good, "But Christmas is for everyone."

The Salvation Army also has food hampers available that contain a variety of nonperishable food items as well as a turkey, potatoes, carrots, and everything to make a scrumptious Christmas dinner.

In order to receive assistance from the Salvation Army, an appointment needs to be made at their office in order to register. The family's entire financial situation is taken into consideration when they register and the Salvation Army agrees to help.

said Ms Good. "These are the families that are employed but are making minimum wage and, as we well know, it is very difficult to support a family on that."

Once the Salvation Army approves the registration, parents are allowed to select a specific number of gifts from the Toy Shop that are age-specific for their children and are given a food hamper before they leave. All the toys that are donated or purchased are new from the stores.

The major challenge facing the Salvation Army this year is finding volunteers to run the kettles at many locations in the community.

In fact, the lack of volunteers has forced the Salvation Army to postpone the beginning of the kettle campaign this year.

"We really need approximately 20 people to help with the kettles that donations are placed in," said Ms Good, "in order to make in a success."

If you can spare a few hours throughout the week to give the Salvation Army a hand in assisting our community, it would be greatly appreciated as would any donations of gifts, money, or non-perishable food items.

"The people in our community are generous all year long," said Ms Good, "but they are even more so at Christmas time."

This year though, the Salvation Army needs people to be generous with their time to help a very worthwhile cause: our community.
