extreme amount of hard work by a group of dedicated volunteers," Ms Eadie said.

The United Way of Milton has been around for the past 20 years, using a variety of methods to raise money.

The 2002 campaign was split into several divisions.

The employers division contacted businesses with more than 25 employees and assisted them in organizing in-house fundraisers, payroll deductions and company donations.

Another division used the good old mail box. Last year, letters were mailed to Milton residents inviting them to donate.

The special events division included the ever-popular Mayor's Golf Tournament. Last year, the event included lunch, golfing and dinner at Granite Ridge Golf Course, and brought in close to \$70,000. There was also a dinner auction and a Christmas House Tour of festively-decorated Milton homes.

There are volunteer committees for each of the divisions.

Ms Eadie said saying thank you to those

involved in the campaign doesn't seem like enough.

"It seems rather inadequate — it's two small words for a huge effort. And we must not forget the donors. Without them, this truly wouldn't happen."

Jim McQueen has been a volunteer with the United Way of Milton for nearly seven years. Mr. McQueen, who is the director of corporate services and treasurer for the Town of Milton, said exceeding the goal was the result of a lot of hard work.

"I thought it was a superior effort last year. At times I wondered if we'd get there. It was a fairly exhaustive year for it."

For the past two years, Mr. McQueen has been the chair of the major employers campaign, and can often be found meeting with company heads, helping them give employees opportunities to support the United Way of Milton in various ways.

"I feel a commitment to the community, and I enjoy the interaction working with the business sector," Mr. McQueen said.

Halton Region is proposing to remove two knolls on 15 Sideroad (Regional Road 15) between 1st Line and 450 m westerly and resurface the portion of 15 Sideroad from 1st Line to the Guelph Railway Spurline. In conjunction with these works, the Town of Milton is proposing to build a walkway on the south side of 15 Sideroad from 1st Line to the Moffat Park.

Halton Region has completed the preliminary and detailed design for the two-lane road reconstruction of Tremaine Road (Regional Road 22) from Lower Base Line to 1200 m south of Britannia Road (Regional Road 6) including the replacement of two new structures No. 22321 and 22322 over Indian Creek, in the Town of Milton. Construction is tentatively scheduled to take place during the 2006 construction season.
