The Town of Milton is honouring its own. Tomorrow, the Town holds its 17th annual Long-term Service Employee Recognition Awards.

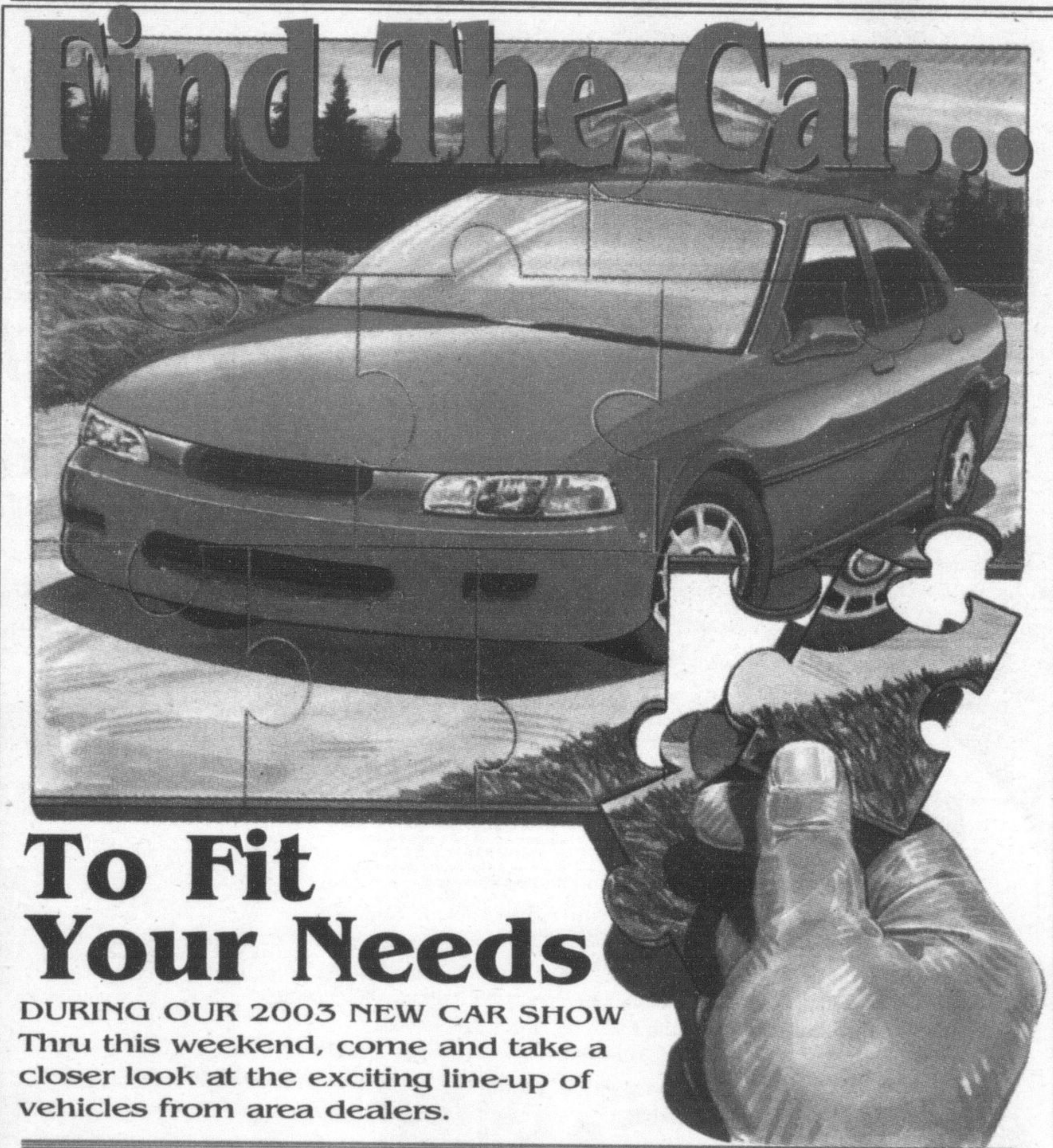
Thirty-three full-time and part-time employees will be recognized for five, 10, 15, 20 and 25 years of service.
