Public health nurses from other parts of the health department, like those who normally work in the smoking cessation program, for example, are helping alleviate the tremendous workload that SARS prevention has become for the communicable disease control section.

Staff are still monitoring other potential communicable disease outbreaks in long-term care facilitates than they normally would.

Medical Officer of Health Dr. Bob Nosal applauding the selfless work of the heath department so far during these crucial times — said he's just thankful the Region was able to ready its program last month to combat West Nile virus, which humans contract from mosquitoes.

"Stating the obvious, to deal with the two of these (SARS and West Nile) at the same time, has had a major, major impact on staff, and I'm glad we submitted the plan (to battle West Nile)

for 2003 in early March before we had to deal with SARS," Dr. Nosal said, in between countless staff meetings and teleconferences with Ministry of Health officials updating the SARS situation.

The plan involves larviciding catch basins and standing pools of water in Oakville and Burlington to kill larvae before they mature into adult mosquitoes that risking carrying West Nile contracted from an infected bird.

Dr. Nosal said what's been learned already from these two emerging infectious diseases is the importance of surveillance.

He said last August he was told of a cluster of encephalitis cases indicative of West Nile infec-

That was part of a sound surveillance program the Region had established, he said.





PROPOSED AMENDMENTS TO THE SMOKING BY-LAW

January 27, 2003 Council of the Town of Milton directed staff to bring forward an amendment to the smoking by-law to permit the implementation of designated smoking rooms (DSR's) by January 1, 2004.

If this amendment is approved by Council, the effect is that on January 1, 2004 no smoking will be permitted in any public place or workplace in the Town of Milton UNLESS IN A DESIGNATED SMOKING ROOM. All public places and workplaces would be permitted to install a DSR that must meet certain criteria already established (such as ventilation rates and seating capacity). Currently the only establishment eligible to have a DSR is a bingo

The proposed by-law will also permit an exemption to the smoking by-law for the Royal Canadian Legion only as well as require open wall space in outdoor enclosures before smoking would be permitted in the enclosure.
