# Tax referendums bad idea, say Town, Region

Halton Region and the Town of Milton are among the hundreds of municipalities that have fired off letters denouncing the Tory government's election proposal to hold referendums on municipal tax hikes.

The Association of Municipalities of Ontario (AMO) said 284 of Ontario's 446 municipalities have so far passed motions opposing an election proposal made by Premier Ernie Eves' Progressive Conservative party in late spring that municipalities would be required to hold a referendum if it was considering a tax increase.

The government must hold an election

by next June.

Municipalities rely heavily on property taxes to pay for services, and politicians and bureaucrats stress tax referendums would impose financial challenges and constraints on budgets that are already

"I guess from the government's point of view it's an easy position to gain favour with the electorate, but that's over-simplistic," said Regional Chair Joyce Savoline. "There needs to be understanding at the provincial level of how municipalities do business."

The Region released a report last week stating that while it's uncommon for a municipality to comment on election platforms, it felt the need to respond as to why it's a bad idea.

"For a number of reasons, this proposal is unworkable in the municipal context," stated the report prepared by the Region's finance staff. "With access to only a single tax base from property assessment, Ontario municipalities lack the diversity to fund services without experiencing tax increases. Diversity, including income, sales, commodity, capital and payroll taxes assists U.S. municipalities to meet this requirement under similar referendum requirements.

"It should be noted that unlike many U.S. jurisdictions, Ontario municipalities are expressly prohibited from running

operating deficits or financing current operations from borrowing."

The Town of Milton passed a motion at its meeting last week decrying the tax referendum issue. Part of the motion states that the budget process is open to all and residents have an opportunity to express their opinion on it.

Mayor Gord Krantz said to hold such a referendum would cost about \$80,000, regardless of how small a tax increase is being proposed.

"If you're looking at it from the point of economics, it absolutely makes no sense," he said.

Hamilton's director of budgets, taxation and policy Robert Rossini said older municipalities like Hamilton are having a difficult time keeping budget's in line.

The city has massive aging water and sewer infrastructure needs, and slow growth generally has made it difficult for the City to deal with those kinds of prob-

"Banning tax increases is a band-aid solution," he said "We need to look at the questions, why are taxes rising and why are budgets under pressure. We need a new deal (with the Province)."

AMO's executive director Pat Vanini said infrastructure is a primary issue with a lot of municipalities.

"Some say we need more capital infusion but the only way is through the property taxes," she said.

Ms Vanini said part of the problem is that upward of 70 per cent of local budgets are saddled with what used to be provincial responsibilities, like social housing and child care.

For every one tax dollar, she said, five cents ends up in the hands of municipalities to run services.


