The conceptual plans are based on community feedback received at an Open House and through surveys conducted in April of this year. These plans can be viewed on the Town website or by visiting one of the following locations.

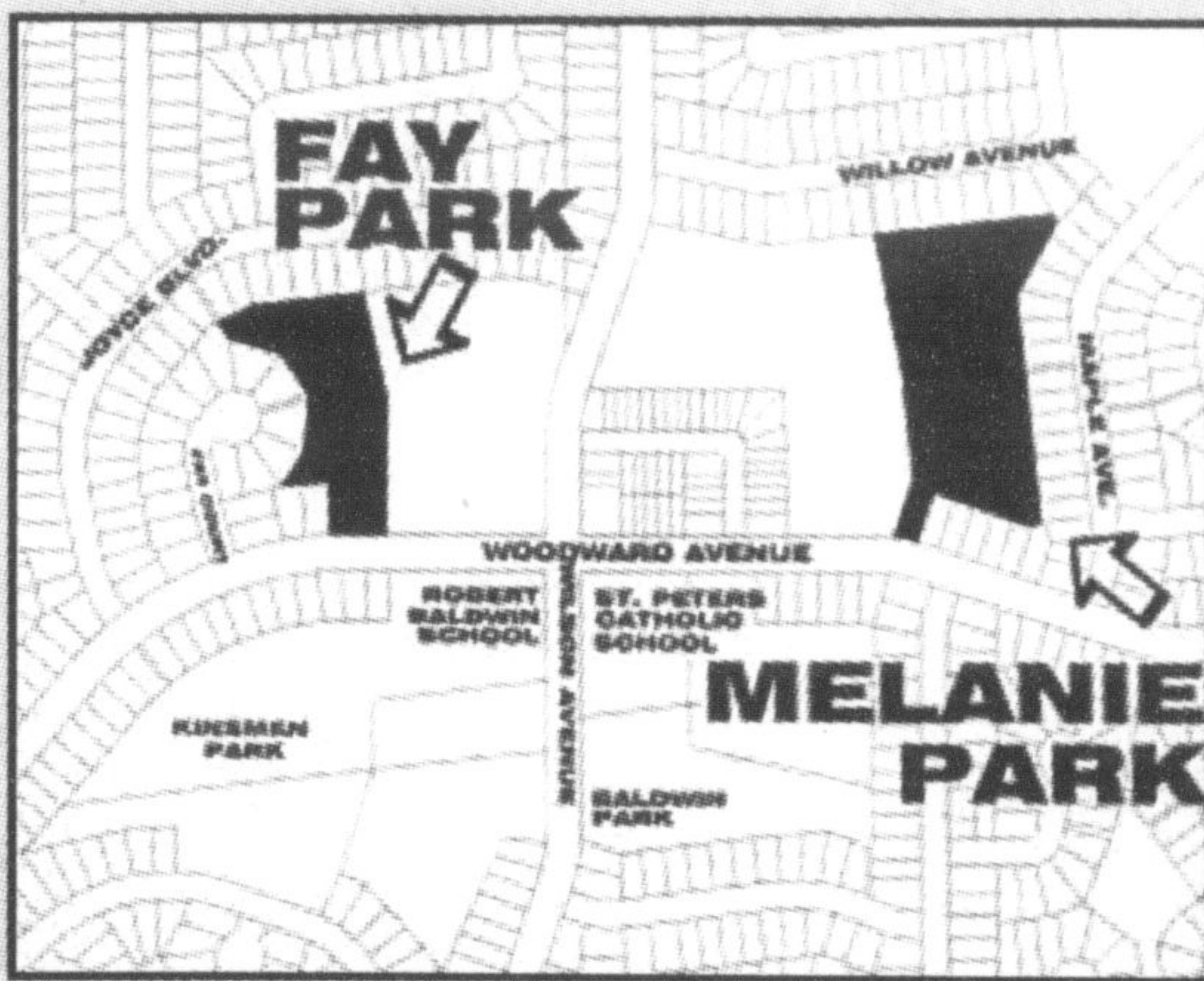

Notice is hereby given pursuant to Section 300 of the Municipal Act, R.S.O. 1990, Chapter M.45, as amended, that the Council of the Town of Milton, at its meeting to be held in Town Hall, 43 Brown Street, on July 28, 2003 beginning at 7:30 pm will consider the passing of by-laws for the temporary closing and replacement of bridges #59 and #69 located on the Sixth Line Nassagaweya between No 5 SR and No. 15 SR:

## LOWER BASE LINE Trafalgar Road to Ninth Line CLASS ENVIRONMENTAL ASSESSMENT STUDY NOTICE OF FILING OF ENVIRONMENTAL STUDY REPORT

Lower Base Line between Trafalgar Road and Ninth Line is a 2 lane rural road with a bridge over Highway 407. In order to address the existing condition of Lower Base Line, the Town of Milton has completed a study of Lower Base Line (from Trafalgar Road to Ninth Line) in accordance with the Municipal Class Environmental Assessment (Class EA) process. The Town retained the firm McCormick Rankin Corporation to carry out this study.

Taking into consideration the problem being addressed, the assessment of alternatives and potential environmental effects, and comments from the public, the 2 lane reconstruction of Lower Base Line is recommended as per preferred Alternative 'C'.

The study has followed the process for a Schedule 'C' project under the Municipal Class Environmental Assessment Process. An Environmental Study Report (ESR) has been prepared and by this Notice is being placed in the public record for review. Subject to the comments received as a result of this Notice, the receipt of the necessary approvals and allocation of appropriate funding, the Town of Milton intends to proceed with construction as identified in the ESR.

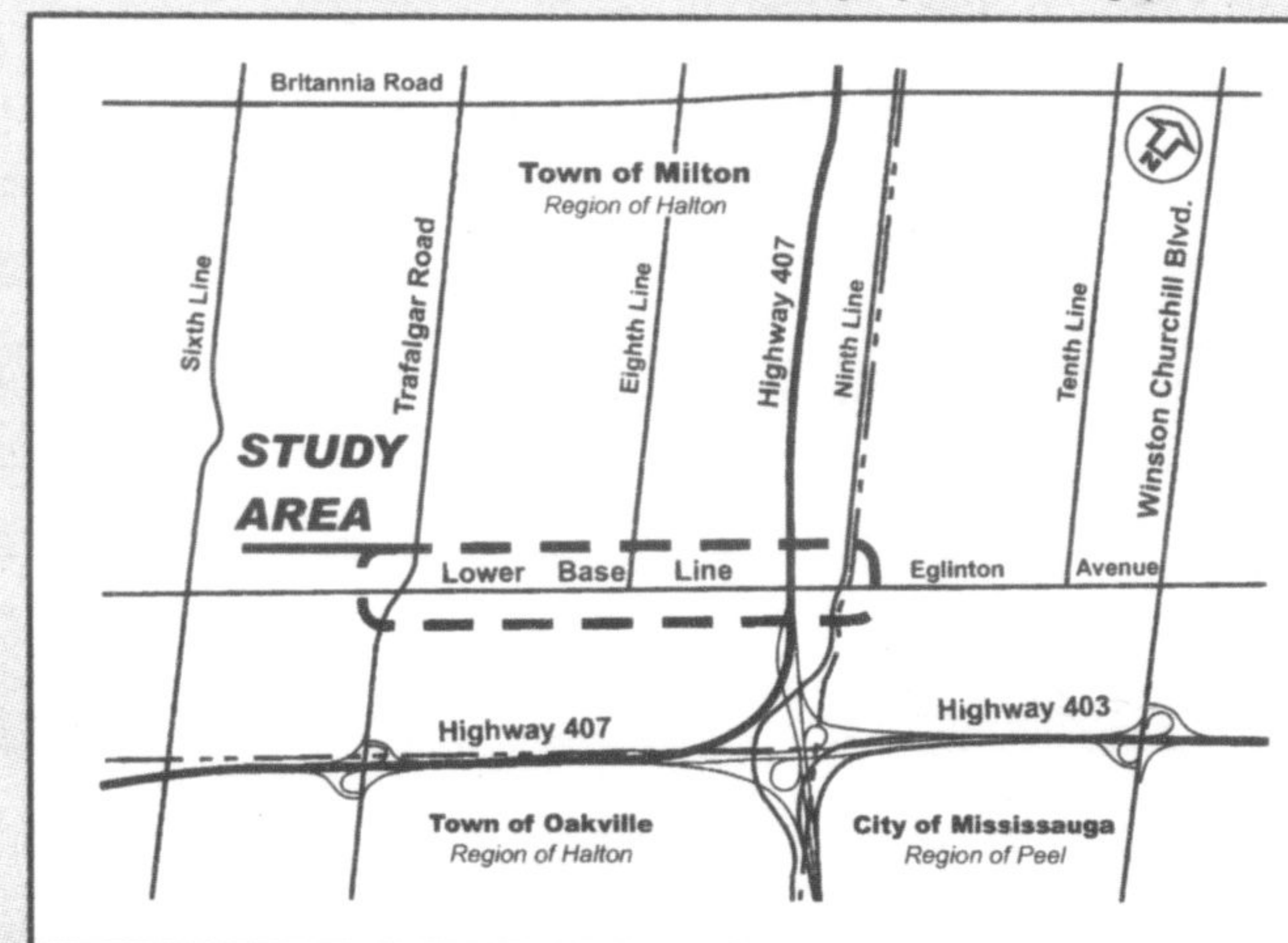

If concerns regarding this project cannot be resolved in discussion with the Town of Milton, a person may request that the Minister of the Environment make an order for the project to comply with Part II of the Environmental Assessment Act (this is referred to as a Part II Order), which addresses individual environmental assessments. Requests must be received by the Minister at the address below by September 15, 2003. A copy of the request must also be sent to the Project Coordinator for the Town of Milton. If no request for a Part II Order is received, the project will proceed to construction as outlined in the ESR.
