### NOTICE OF ESR SUBMISSION


Sixth Line Improvements From Lower Base Line to 0.4 km North of the Bailey Bridge at East Sixteen Mile Creek Town of Milton

#### The Study

The preliminary design study investigating improvements to Sixth Line from Lower Base Line to 0.4 km north of the Bailey bridge at East Sixteen Mile Creek, a distance of approximately 1.9 km, is now complete.

The preferred design concept for improvements to Sixth Line includes the following main components:

- pavement rehabilitation and the addition of 1.2 m gravel shoulders to provide a safety zone for disabled vehicles;
- improvements to the horizontal alignment and vertical profile of the Bailey bridge at East Sixteen Mile Creek; and,
- replacement of the existing Bailey bridge with a new two-lane single span structure with concrete abutments. The new bridge alignment will maintain the existing roadway footprint where possi-



Sixth Line within the project limits will be constructed to a 60 km/h design speed and will have a posted speed of 50 km/h.

LEA Consulting Ltd. managed the study on behalf of the Town of Milton. LGL Limited provided environmental design and planning services on behalf of LEA.

#### The Process

The study followed the approved planning process for Schedule "C" projects in accordance with the "Municipal Class Environmental Assessment" (MEA 2000), with the opportunity for public input throughout.

An Environmental Study Report (ESR) will be available on August 1, 2003 for a 60day public review period. Interested persons are encouraged to review this document and provide comments before September 30, 2003. If, after consulting with the Town of Milton's consultants and staff, you have serious unresolved concerns, you have the right to request a Part II Order for this project from the Minister of the Environment (135 St. Clair Avenue West, Toronto, M4V 1P5). A Part II Order may lead to the preparation of an individual environmental assessment. A copy of the request should be forwarded to the Town of Milton and LEA Consulting Ltd. at the addresses noted below. If there are no outstanding concerns after September 30, 2003, the project will be considered to have met the requirements of the Class EA.

### Escaped youths rounded up

Tracking dogs located three youths last week after an escape from an area group home prompted a police search.

On July 24 at 6 p.m., Halton Regional Police received a report that three male youths had escaped from the Macmillan Youth Centre on Boston Church Road.

Constable Lisa Scott and her dog, Gage, were called to assist officers from 12 division, the criminal investigations bureau and the tactical and rescue unit.

"We got a nice start," said Const. Scott. "The staff pointed us in the direction the youths were seen leaving."

Rick Lostracco, and his dog, Honour, took over.


