Why are you running?

What are the local issues?

The present population of urban Milton is roughly 35,000, but the planners and developers are proposing building houses for yet another 35,000 people within an unbelievable five years. Many of our subdivisions are experiencing problems with roads and servicing and parking, which quickly turn into safety issues, especially for children. How will you address them?

My view is that, except for true legal commitments and infilling, there should be a moratorium on large-scale increases in residential development for the next term of council. We need time to allow our new residents to be assimilated into our community and to get them the services and safety they have paid for, especially doing all we can to get commuter traffic off our local roads. We have to count our blessings in Milton and protect our lifestyles.



He has lived in Milton his entire life and has volunteered and worked locally. He was a delivery boy for The Champion for eight years. From this experience, he began to develop an interest in serving Milton. During his teenage years, he worked at local fast food restaurants. He currently volunteers in the local citizens' group Pesticide Alternatives for Milton as director at large. He's also active in two clubs at the university level.

Why are you running?

I am deeply concerned with issues surrounding the growth that Milton is now experiencing, and I would like to be more actively involved in future planning. I would also like to be more

actively involved in the community in which I live. As well, I feel strongly that the duty of politicians is to be responsive to the people they represent, and one of my primary goals is to be available and responsive to my constituents.

What are the local issues?

Issues that have been expressed to me by residents include the preservation of greenspace, the issue of the placement of bicycle paths in the new subdivisions, which as proposed will cut through residents' properties, and a desire for

improved bus service. As well, some residents have expressed a desire to see the town's policy on cosmetic pesticide use re-examined. Also, residents in the new subdivision have expressed a concern over parking bylaws.

How will you address them?

I would address the issue of bicycle paths by looking at alternative possibilities and would work toward ensuring that better planning is done for future subdivisions. Regarding bus service, I think that service to the new areas should be on par with that of the rest of Milton (if it is not already), and I would be open to examining the possibilities of increasing bus service in general, finances permitting. In planning future development, I would work to ensure that the planning takes into account the necessity of preserving greenspace. Finally, I would bring to town council's attention the issue of the health effects of cosmetic pesticides. In terms of parking bylaws, I will examine the feasibility of suspending bylaws or constructing common parking lots, in order to alleviate the problem.
