IN THE MATTER OF the *Consolidated Hearings Act*, R.S.O. 1990, c.C.29, as amended, and

IN THE MATTER OF a proposal by the Proponent, Dufferin Aggregates, A Division of St. Lawrence Cement Inc.

The members of the Board (called a "Joint Board") appointed under the Consolidated Hearings Act, R.S.O. 1999, c.C.29, as amended, to hear and adjudicate the applications of Dufferin Aggregates, a Division of St. Lawrence Cement Inc. related to the proposed Milton Quarry Expansion, commenced hearing on January 12, 2004.

The Joint Board hereby invites the public to attend a special evening session to be held on Tuesday, February 10, 2004, from 7:00 p.m. to 9:00 p.m. at the Town of Milton Council Chambers located at 43 Brown Street, Milton. The Joint Board will also hold a second special evening session for the public on Wednesday, February 25, 2004, from 7:00 p.m. to 9:00 p.m. at the Town of Milton Council Chambers. The following matters are before the Joint Board:

In order to proceed with this undertaking the proponents have filed:

- (1) An application to amend the Niagara Escarpment Plan, pursuant to Section 10(5) of the *Niagara Escarpment Planning and Development Act*; and
- (2) An application for a development permit under section 25 of the *Niagara Escarpment Planning and Development Act*; and
- (3) Applications for amendments to the official plans of the Region of Halton, the Town of Halton Hills and the Town of Milton pursuant to the *Planning Act*, R.S.P.O. 1990, c.P.13; and
- (4) An application to amend the zoning by-law of the Town of Milton pursuant to the *Planning Act*; and
- (5) An application for a class "A" license to operate a quarry pursuant to the *Aggregate Resources Act*, R.S.O. 1990, c.A.8.

The Joint Board will hear and adjudicate the matters noted above pursuant to the provisions of the *Consolidated Hearings Act*.

The purpose of a Joint Board Hearing is to hear all of the issues related to the undertaking at one time, rather than having separate hearings.
