
Holiday Waste Collection

You can help reduce litter with some simple steps to prevent your recyclables from taking flight on windy days. Please ensure your blue box materials are placed curbside in a secure manner.



 On windy days, place your blue boxes out for collection on the morning of collection day by 7:00 a.m. instead of the night before.

 If possible, stack your blue boxes on top of one another to prevent papers from blowing away.

- · Fill boxboard boxes with other boxboard material.
- Place heavier items on top of lighter items.
- Flatten and tie large cardboard boxes and place securely underneath or between your recycling boxes.

RECONSTRUCTION OF DERRY ROAD (REGIONAL ROAD 7) FROM THOMPSON ROAD SOUTH TO JAMES SNOW PARKWAY (REGIONAL ROAD 4) TOWN OF MILTON

Halton Region is currently planning for the four-lane road reconstruction of Derry Road (Regional Road 7) from Thompson Road to James Snow Parkway (Regional Road 4) including replacement of culvert structure No. 07334 over the East Branch of the 16 Mile Creek, in the Town of Milton. Construction is tentatively scheduled to take place during the 2004 construction season.

The project followed the Municipal Class EA Process, which involved public consultations and the publishing of an Environmental Study Report in May 2003. You are invited to attend this Public Information Centre to review the preliminary design and discuss any construction related matters with representatives of Halton Region. 
