

hearing to continue next month

The joint board considering the Dufferin Aggregates Milton quarry expansion heard the final plea for it to turn the application down from two local environmental groups earlier this week.

Toronto solicitor Joseph Castrilli came before the Ontario Municipal Board and Environmental Review tribunal Monday and Tuesday to present his final arguments against the potential expansion on behalf of the Coalition on the Niagara Escarpment (CONE) and Protect our Water and Environment Resources (POWER).

The joint board will decide whether or not the 85-hectare quarry extension proposal, which straddles the Milton/Halton Hills border, will go ahead.

Mr. Castrilli presented three days worth of technical evidence and arguments on issues surrounding everything from water to the natural environment.

He spent a lot of time reviewing the potential impact the quarry expansion could have on the Jefferson salamander, a rare species that's found in the Halton Forest and surrounding area.

He said the salamander could attempt to migrate across an open field found in the quarry expansion area and the alteration or removal of this migration route could severely impact the population of the nationally-threatened animal.

"The evidence in our submission is both persuasive and overwhelming that Jefferson salamander migration route studies should have been, but were not done in the open fields," he told the board. "Unless you do the study, you'll never know."

Dufferin's lawyer Jonathan Kahn earlier argued that experts hired by the aggregate company said salamander migration across open fields is atypical and any related studies would be "unnecessary and unduly onerous."

Mr. Castrilli also heavily criticized Dufferin's position that there's a large need for the expansion to meet the demand for crushed stone.

Mr. Kahn previously told the board that the existing Milton quarry is expected to be mined out by 2007, making timing critical.

He also said that 30 to 40 per cent of crushed stone production in the GTA comes from the Milton quarry.

"The applicant's evidence on the need for 10 to 12 more years of aggregate is neither so strong, nor so convincing, that the company should be allowed to excavate another large chunk of what makes the Niagara Escarpment so unique," Mr. Castrilli said. "Extraction reduces a natural resource that cannot be replaced."

The environmental monitoring plan, known as the Adaptive Environmental Management and Protection Plan (AMP), was another aspect of Dufferin's application that came under fire.

The document stipulates that Dufferin must cease extraction if the AMP is not effective in raising groundwater levels above target.

But Mr. Castrilli noted that "cease extraction is not as draconian a club for compliance as the applicant makes it out to be, particularly if you are an on-site wetland."

He concluded his case by recommending • see DUFFERIN on page 8
