## MADD launches Halton Red Ribbon campaign

More than four million red ribbons will be tied onto Canadian vehicles this month, as proof of the commitment drivers across the country are making to staying sober behind the wheel.

That commitment signals significant progress in the battle against impaired driving - a battle that's made the term 'designated driver' as common as the old "one for the road" expression once was.

In 1980, alcohol was involved in about 60 per cent of the deaths on Canadian highways. Nowadays, it's only a factor in about 37 per cent of fatalities.

Still, Andrew Murie, CEO of MADD Canada, believes there's more that can be done.

At the kick-off for this year's MADD Halton-Peel regional Red Ribbon campaign, Mr. Murie said Canada must change the rules around how much someone can drink and still drive legally.

Under the current legislation regarding bloodalcohol levels, Mr. Murie said, a 200-pound man can drink seven beers on an empty stomach over a two-hour period and face only a 12-hour licence suspension if caught driving.

He said MADD, along with many Canadians, believe that lower blood-alcohol levels should be required for drivers.

Mr. Murie said that the organization, dedicated to stopping impaired driving, would also like to

see drivers age 21 or younger be required to maintain zero per cent blood-alcohol levels, as part of graduated licencing.

He noted that 18 and 19-year-old males are suffering the vast majority of deaths and serious injuries in alcohol-related collisions, and

described the mixture of a full licence and the legal right to drink as "a lethal combination."

Finally, Mr. Murie added, MADD wants to see more done about the problem of suspended drivers who don't show up for rehabilitation programs and often simply drive without a valid licence and insurance.

An Ontario study of drivers who had their licences suspended for impaired driving found that only 50 per cent of first-time offenders were enrolling in the programs they needed to have their licences returned.

Similarly, about 28,000 drivers are currently eligible to drive if they install an alcohol interlock technology in their vehicle, but only 2,000 drivers are currently using it.

Gary Crowell — deputy chief of the Halton Regional Police — told Tuesday morning's Red Ribbon campaign launch-goers that he's concerned about the proliferation of alcohol in society, as well as the glossy advertising campaigns that encourage the concept of drinking to have

Deputy Chief Crowell also expressed concern about the message the federal government may be sending to young people with its plans to decriminalize possession of small amounts of marijuana.

"While alcohol is certainly contributing to the deaths on our roads, so are drugs, so let's not forget that," he said.

Milton Mayor Gord Krantz said that he believes MADD has been quite successful in its education of young people.

"People from my era – I don't think we were as responsible as the young people of today," he said.






