### Notice of Proposed By-Law

#### Outdoor Solid Fuel Combustion Appliances

The Administration and Planning Committee of Council will be considering a proposed by-law to regulate outdoor solid fuel combustion appliances due to public nuisance. Outdoor solid fuel combustion appliances burn a solid fuel such as wood and are used to heat a main structure but are located outside of the structure or in an exterior structure similar to a garden shed. The heat from the unit is then piped into the main structure. This proposed by-law does not pertain to such items as chimeneas or other open air burning.

The by-law, if passed, would require outdoor solid fuel combustion appliances to be located at least 150 metres from side and rear yard property boundaries and at least 130 metres from front yard boundaries.

The Administration and Planning Committee meeting will be held on Monday, February 21, 2004 at 7:30 p.m. in the Council Chambers at Town Hall, 43 Brown Street. ## Funds sought to expand tobacco control programs

The Region has applied to the Province for \$1.4 million in funding to ensure the expansion of existing local tobacco control programs and the development of a Halton comprehensive tobacco strategy.

The health department submitted applications in four funding categories — policy promotion and enforcement, worksite innovations, innovative smoking intervention programs and youth action alliance.

If approved, the money would be used for things like hiring additional inspection staff, expanding tobacco cessation services and providing health promotion activities

that highlight the association between oral health and tobacco use.

The funds would come from the Ministry of Health and Long-Term Care.

A report from Medical Officer of Health Dr. Bob Nosal said the ministry "is responding not only to the overwhelming evidence of the health risks associated with tobacco use, but also to recent surveys which clearly indicate public support for increased spending on tobacco control programs."

Staff will report back to council once the funding level is confirmed.
