25-acre subdivision proposed

A small residential development has been proposed for an approximate 25-acre parcel of land on Derry Road, west of Fourth Line.

The proposal, put forward by Transcon Properties Ltd. of Hornby, consists of 59 single-detached homes, 48 semi-detached houses, a neighbourhood centre with 80 stacked townhouse units, 40 two-storey townhouses and six loft apartments, a park and woodlot. The lands are located within the Bristol Survey secondary plan area.

A staff report on the proposed plan of subdivision came before the Town's administration and planning committee Monday night for information purposes and a public meeting.

While the draft plans submitted to the Town include 468 square metres of commercial space, Transcon representative York Gruehl told the committee this component is being excluded at this time.

The committee only heard from two individuals on the proposal, one who expressed concerns on what the commercial space would be used for and the other who requested clarification on the woodlot.

The staff report noted that Transcon is asking for a zoning bylaw amendment to change the property from a future development zone to residential medium density and open space.

Several reports and studies have been submitted to the Town in support of the application, including a traffic impact assessment, noise impact feasibility study, woodlot assessment study and archeological assessment.

Once the Town has received all comments on the proposal and the application evaluation is completed, a technical report with recommendations will be brought back to committee and council.

Tree case postponed

The defence in a high-profile case involving acres of tree-cutting has been granted an adjournment until next month.

David Crocker told Justice of the Peace J. Woloschuk at Ontario Provincial Offences Court in Milton yesterday he wasn't able to proceed with a cross-examination, and to attempt it would be to fail his client — Burlington resident George Vastis.

Mr. Crocker was to have cross-examined a lawyer — June Kim — who swore an affidavit of the prosecution.

Mr. Vastis is facing \$840,000 in fines for 44 counts of cutting in a woodlot and cutting in an Environmentally Sensitive Area.

The clearing activity took place in 2003 on a Fourth Line property he owns on the Milton/Oakville border.

He pleaded not guilty to the charges last year.

In January, the defence filed a motion requesting a stay of proceedings — that the case be thrown out — telling court Crown prosecutor John Olah had failed to provide full disclosure.

Mr. Crocker explained yesterday the prosecution felt it necessary to respond to the defence's allegations with an affidavit. That makes the person who swore the affidavit open for cross-examination.

The case will continue March 23 at Ontario Provincial Offences Court in Burlington.
