NOTICE OF ROAD CLOSURE AND SALE

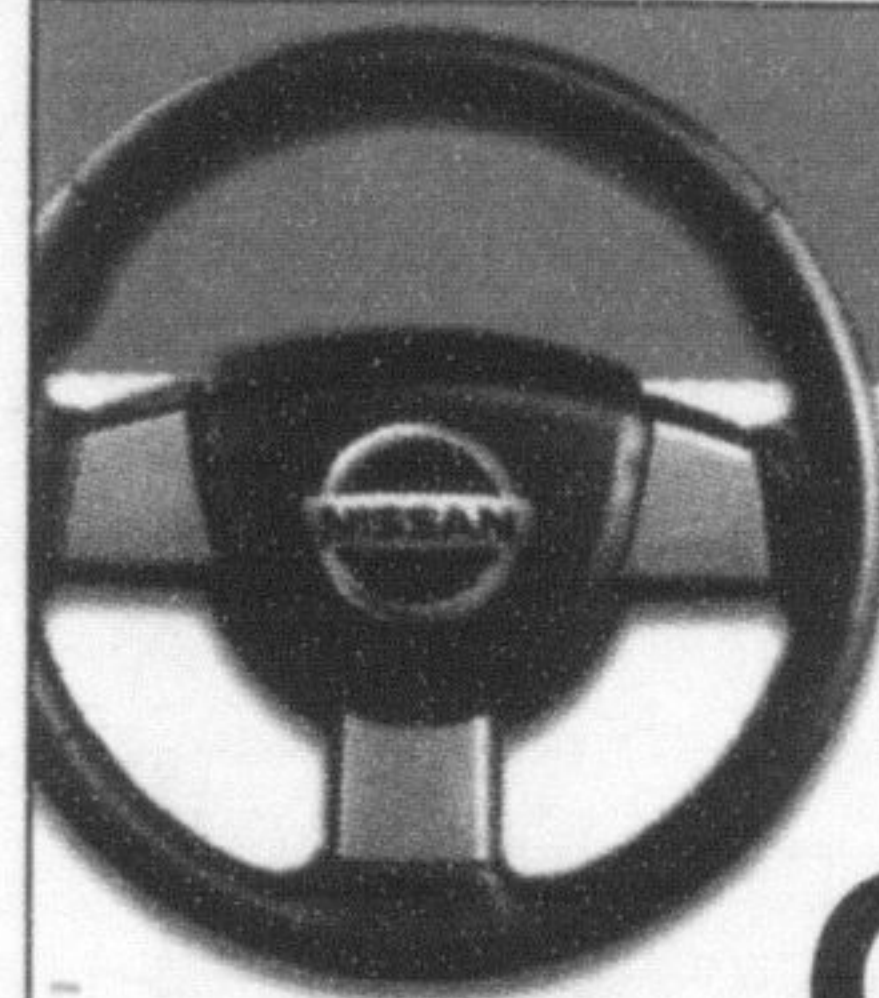
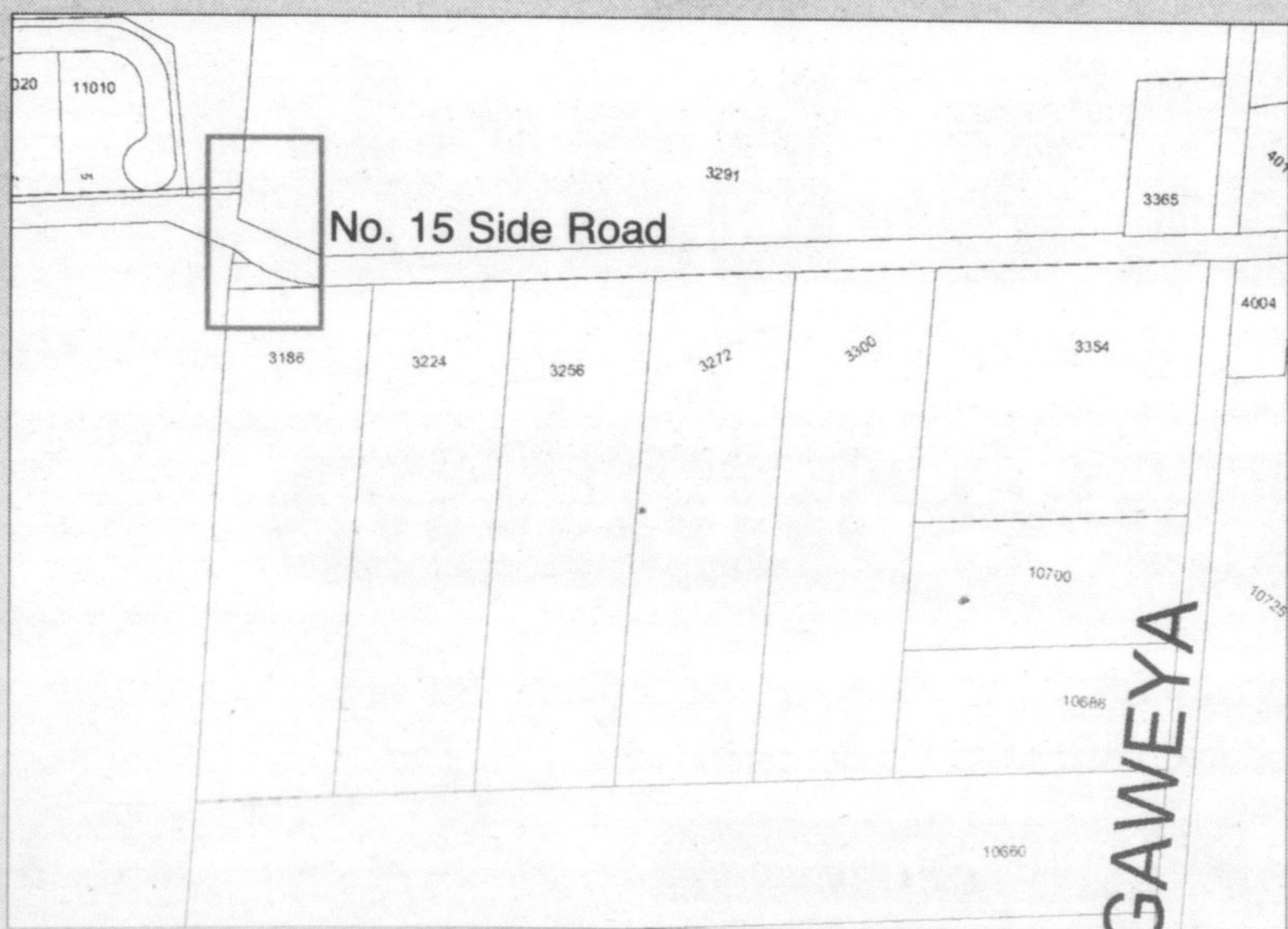

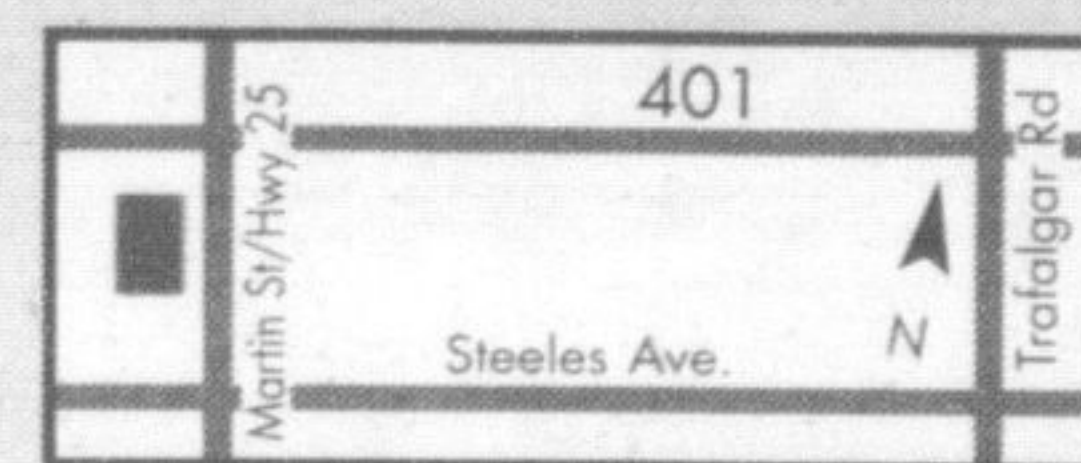
