At about 3:35 a.m., police responded to an alarm activation and found the video store's rear glass door smashed with a rock and the rental games missing.

Impaired charges laid

A 51-year-old Oakville man faces charges in connection with a motor vehicle collision on Ninth Line and Britannia Road Saturday afternoon.

Charged with impaired driving and having over the legal limit of alcohol in his blood, the suspect will appear in Burlington provincial court April 19.

Fraud case in court

A Milton couple facing numerous charges in connection with a series of mortgage frauds will return to Ontario Court of Justice in Newmarket May 6 for the continuation of their pre-trial.

Frank Basso, 47, and his wife, Catherine, 46, both of Rutledge Road, were charged with a total of 16 and 10 counts respectively of fraud over \$5,000, conspiracy to commit fraud, uttering a forged document, obtaining money by a forged document and obtaining credit by false pretence along with three other non-Milton residents.

The pre-trial got underway last Friday at Newmarket court. A pre-trial is held to hammer out legal issues before a trial.

The charges relate to two incidents in 2001 and 2002 in which fraudulent mortgages were arranged on houses unbeknownst to the owners — relatives of the suspects — to obtain money.

York Regional Police allege \$1.7 million was pocketed by the five suspects from a total of three incidents in Toronto and Vaughan, one in which no charges were laid against the Milton couple.

Milton Mall kiosk broken into


Halton Regional Police are investigating a break-in at a kiosk at Milton Mall.
