# Immunization clinics to be held for grade 7 students in Halton

The Halton Region Health Department will hold Men C (meningococcus group C) immunization clinics next month in local schools for grade 7 students.

Information packages about the Men C vaccine were sent home with students in early March.

"The health department is pleased to be working with local schools on Men C immunization," said Regional Chair Joyce Savoline. "This partnership is a great way to reach our common goal of maintaining children's health and protecting them from infections."

Meningococcal bacteria have five groups — of which group C is one — that can cause meningitis, bacteremia or both. Meningitis is an infection of the membranes and fluid that cover the brain and spinal cord. Bacteremia is an infection of the bloodstream that, in its worst form, is called septicemia.

Illness can appear suddenly with fever, chills, a rash and a very sick, weak feeling. Severe headache and a stiff neck usually occur in the case of meningitis. About one in 10 patients die of the disease even with prompt diagnosis and appropriate treatment.

Meningococcal bacteria require close, direct contact to spread. Kissing, coughing and sneezing are the main routes, though sometimes it can also be spread through saliva when sharing things like cigarettes, lipstick, food or drinks via their utensils or containers, toothbrushes, toys, mouth guards or musical instruments with mouthpieces.

Meningococcus group C bacteria account for roughly one out of every four cases of meningococcal disease in Ontario and is most

common in the teen and young adult years. The Men C vaccine protects against group C, but not against other meningococcal groups.

The Men C immunization program is part of the recent expansion of the publicly-funded vaccines. Vaccines for chickenpox, Men C and pneumococcal disease are now available free of charge for those who meet the eligibility criteria.

An Orillia man charged with manslaughter in connection with the death of a Milton dentist will return to court May 2.

Adam Holland, 21, appeared at Ontario Court of Justice in Orillia March 14 to set the return date.

Dr. David Dumencu, 42, was found lying unconscious with head injuries in the parking lot of an Orillia-area tavern at about 2 a.m. July 16 of last year.

He was taken to an Orillia hospital and then transferred to Toronto Western Hospital where he died two days later.

A post mortem revealed the cause of death was a blunt force head injury.

# Mattamy looks to build another subdivision here

Housing development giant Mattamy Homes has put forward plans for a new subdivision south of Derry Road, between Thompson Road and Regional Road 25.

The proposal for the approximate 95-acre piece of land that was formerly used for agricultural purposes includes 558 single-detached residential lots, a village square, linear park, open space and an internal road system.

The plans came before the Town's administration and planning committee Monday night and were received for information purposes.

Mattamy has also asked for a zoning bylaw amendment to change the land from a future development zone to residential medium density, greenlands and open space.

A number of reports and studies have been submitted to the Town in support of the application, including a traffic impact study, noise impact feasibility study, natural heritage review and archaeological assessment.

A technical report and staff recommendation on the plan's approval or refusal will be brought forward once a full review of the application has been completed.

#### THE STUDY:

The Ontario Ministry of Transportation (MTO) is working to provide for the efficient movement of people and goods within the context of the province's draft Growth Plan for the Greater Golden Horseshoe. In order to realize the transportation objectives of the draft Plan, MTO has prepared a draft Environmental Assessment (EA) Terms of Reference (ToR) for the Niagara to GTA corridor.
