Housing strategy work plan endorsed by council

Regional council endorsed a steering committee work plan Wednesday to develop a comprehensive housing strategy for Halton.

The initiative will incorporate a continuum of housing types for all incomes and stages of life, from emergency shelters and government-assisted housing to private sector affordable housing.

The steering committee is comprised of four Regional councillors — Burlington Councillor Rick Craven, Oakville Councillor Mike Lansdown, Halton Hills Councillor Clark Somerville and Milton Councillor Ron Furik.

It's chaired by Regional Chair Joyce Savoline. Senior staff and Halton's Housing Advisory Committee co-chair Maria Robinson are also active participants on the committee.

"Creating a comprehensive housing strategy is a new and exciting venture for Halton," said Ms Savoline.

"Our strategy focuses on one main principle - to allow Halton residents to remain in their own community. That means creating a supply of housing, protecting the supply and ensuring it meets the individual needs of our changing

demographics, from low-income residents to young adults to seniors and everyone in between."

To develop the strategy, a collaborative and broad-based participatory public and stakeholder approach will be undertaken using a wide variety of tools.

Key activities include consultation with Halton's human servicès advisory committees, which happened Wednesday, as well as presentations to local municipalities, a housing visioning session May 17, a public kick-off event June 14

and a best practices workshop June 29.

In addition, Ipsos-Reid, a nationally-renowned Canadian public opinion research firm will be conducting a series of randomly-selected telephone interviews with Halton residents to determine a baseline of public opinions and attitudes about housing in Halton.

This research will be conducted from Friday to May 16, with the findings being reported to the steering committee and Regional council, along with results from other consultative efforts.
