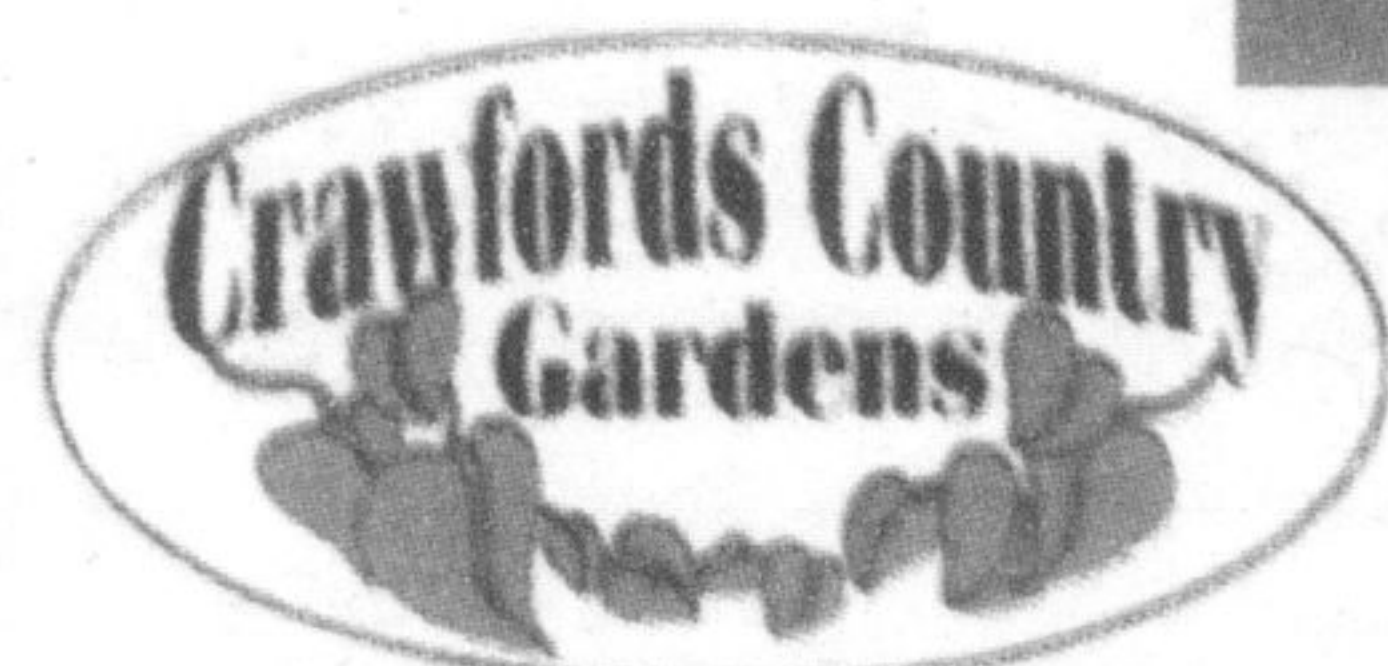

Event a community effort

If the number of calls he has received is any indication, this Saturday's Milton Good Neighbours Community Day — the 13th year of the event — is going to be a mighty successful one, suggested chairman Len Lee.

But that doesn't mean he's done with recruiting. Quite the opposite — he's continuing to urge as many people as possible to participate.

Following a breakfast barbecue — featuring the Rotary Club's famous 'bacon on a bun' — at 8 a.m. in Victoria Park, residents will get to work lending a hand to those who need it.

They'll be assigned their tasks and, if necessary, their equipment.

The volunteer experience, Mr. Lee stressed, is certainly rewarding for all participants.

"I've been involved since day one. It's always great, especially to help seniors who are so pleased we

came and helped. It makes it very rewarding," he said.

Each volunteer will be given a 'Good Neighbours Community Day' t-shirt for identity and security purposes.

Participants might take down storm windows, clean a yard, dig a garden or wash windows — whatever tasks seniors and other residents are unable to do themselves.

In the past few years, the event has expanded with participants also cleaning riverbeds around town. There's never a shortage of waste to remove, Mr. Lee said.

"Last year we took out a treadmill, a couple of years before it was a computer and, of course, there are always the carts," Mr. Lee said.

Students from the three local high schools as well as Scouts, Air Cadets and Brownie organizations will take part.

Officers from the local RCMP

and Halton Regional Police Service will be driving to the various sites with drinks, fruit and supplies.

Some of the event's supporters include the Town of Milton, the Milton Community Resource Centre, the Milton Good Neighbours Committee and TD/Canada Trust. Most of the food and supplies are being donated by local businesses.

"There are so many people in town who are showing their support," Mr. Lee said.

Those who'd like to participate are asked to fill out a form at the Milton Seniors' Activity Centre, Milton Town Hall, Milton Public Library, Milton Chamber of Commerce or the Canadian Champion.

MAIN STREET EAST & THOMPSON ROAD SOUTH CPR GRADE SEPARATIONS CLASS ENVIRONMENTAL ASSESSMENT STUDY

NOTICE OF PUBLIC INFORMATION CENTRE

The Canadian Pacific Railway (CPR) has two level crossings within the urban area of Milton. One is located on Main Street East, immediately east of Ontario Street. The other is located on Thompson Road South, south of Main Street East. These level crossings presently impact the operation of both roadways and the surrounding road network. Grade separations are warranted at both locations based on rail and road traffic volumes.

Therefore, the Town of Milton is carrying out a study of Main Street East & Thompson Road South CPR Grade Separations, in accordance with the Municipal Class Environmental Assessment (Class EA) process, which is approved under the Ontario Environmental Assessment Act. McCormick Rankin Corporation has been retained to assist in carrying out the study.

The study areas for both crossings are shown below. In 2001, the Town completed an Environmental Study Report (ESR) recommending the widening of Thompson Road to 4 lanes from Derry Road to Steeles Avenue. As a grade separation is now warranted, the Town is considering combining these projects.

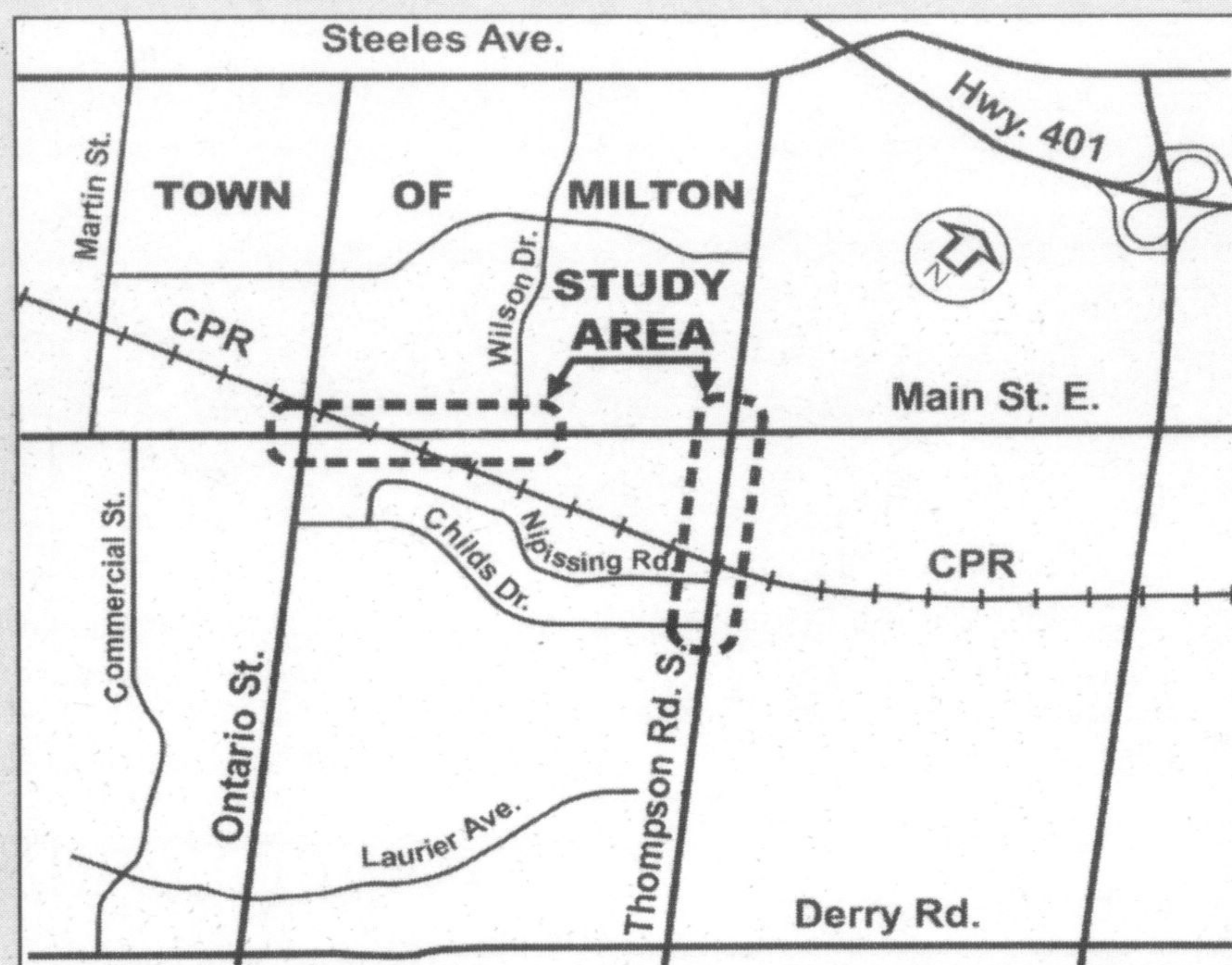
A Public Information Centre has been arranged for:

The purpose of the information centre is two-fold:

- 1) Thompson Road South:** to review the alternatives and the preliminary plan for the preferred alternative for the proposed CPR grade separation. Thereafter, the preferred alternative will be reviewed in light of comments received and an Addendum to the 2001 ESR is proposed to be filed in June 2005 for public review.
- 2) Main Street East:** to review the alternatives for the proposed CPR grade separation. Thereafter, the preferred alternative will be determined and a second information centre will be held in fall 2005.

NOTICE TO PROPERTY OWNERS TO DESTROY NOXIOUS WEEDS

NOTICE IS HEREBY GIVEN to all persons in possession of land, in accordance with The Weed Control Act, R.S.O. 1990, Chapter W.5, Sections 3, 13, 14, 16 and 23 that, unless weed seeds and noxious weeds growing on their lands within the Town of Milton are destroyed by the date of June 15th, 2005 and throughout the season, the Town of Milton may enter upon the said lands and have the weeds destroyed, charging the costs against the land in taxes as set out in The Weed Control Act.

The co-operation of all property owners is earnestly solicited. Complaints and inquiries may be made by telephone, to the number listed below. **Please note that dandelions, burdock and goldenrod are not considered noxious weeds within the Town of Milton under The Weed Control Act; therefore, complaints concerning these weeds or any anonymous complaints cannot be accepted.**
