
Please drive safe





Any resident of the municipality may make a written submission as to whether the issuance of the licence is in the public interest having regard to the needs and wishes of the residents. Submissions must be received no later than June 19, 2005. Please include your name, address and telephone number. If petition is submitted to the Commission, please identify the designated contact person. Note: The AGCO gives the applicant copies of any objections. Anonymous objections are not considered.

The personal information gathered is collected under the authority of the Liquor Licence Act. The principal purpose of the collection is to assess eligibility for the issuance of a liquor sales licence. Copies of all objections are given to the applicant. The information may also be disclosed pursuant to the Freedom of Information and Protection of Privacy Act.
