Three-way stop signs may be put in at intersections

The Town will soon be taking another look at whether the intersections of Coxe Boulevard with Laurier Avenue and Childs Drive should become three-way stops.

Milton council debated the topic Monday evening after Ward 4 Councillor John Challinor brought forward a motion calling for staff to report back on the possibility of placing three-way stop signage at the busy intersections.

Staff responded to Mr. Challinor's initial inquiry on the matter with a letter detailing the traffic counts that were completed at the intersections. The letter concluded "allway stops are not warranted at this time."

"I really think that engineering should just take another look at it," Mr. Challinor argued at the council meeting. "I think council deserves the opportunity to think about it."

But, Ward 3 Councillor Jan Mowbray cautioned the Town against putting in more stop signs, noting they can impede emergency services.

"One minute can be the window of opportunity for a critically injured child," she said.

"Somebody's life could be at stake by putting in a stop sign."

She added that more and more people are making rolling stops at stop signs, which creates more problems.

Ward 4 Councillor Wendy Schau said she spoke with the crossing guard at the corner of Laurier and Coxe, who also raised concerns about people making rolling stops at the intersection.

Mr. Challinor's motion carried. Director of Engineering Services Paul Cripps said staff would like to wait until the fall to redo the traffic counts, noting the numbers would be more accurate since many residents will be on vacation now.

Town looking into urban tree bylaw

Ward 4 Councillor John Challinor brought forward a motion on the group's behalf at council Monday evening, asking Town staff to look into the feasibility of introducing a bylaw prohibiting the injuring or destruction of trees in urban Milton.

He explained Heritage Milton asked for this motion as a result of two recent incidents where property owners cut down "signifi-

Heritage Milton is looking to cant' trees in central Milton, one in an act of defiance against their neighbours and the other against the Town.

The latter, he said, involved a development where the Town wasn't supportive of the size of the structure proposed. The tree in this scenario, a walnut tree, he said was then cut down because of the revenue it represented, cabinet making.

Mr. Challinor noted that he had a bit of hesitation about introducing the motion because of the tree bylaw Halton is working on and also because he feels very strongly about property rights.

He went on to say that trees in the town's business district do have heritage and that trees can be designated through the Heritage Act, but currently none in Milton have received that label.

Wards 1 and 3 Councillor Barry since it's often used for things like Lee directed staff to consider tree designations under the Heritage

Council supported the motion.

Fireworks bylaw may be updated

A local councillor's concern about public safety when it comes to fireworks has sparked a call for Town staff to take a second look at Milton's existing fireworks bylaw.

Ward 4 Councillor John Challinor brought forward a motion at council Monday evening asking for staff to report back on the feasibility of updating the bylaw to include storage requirements, vendor licensing requirements and annual fireworks bylaw notification to the public.

"Over the last 14 years that I have served as an elected representative, I have become increasingly concerned about the conduct of some who sell and some who buy consumer fireworks," said Mr. Challinor in a letter that went before council.

Council supported Mr. Challinor's motion.



The purpose and effect of these housekeeping amendments are as follows:

Greenlands A Amendment: To clarify the intent with respect to the Greenlands Azone. This zone identifies lands regulated by the Conservation Authority. This amendment will authorize certain land uses, which are permitted by the Conservation Authority through their permitting process.

Greenlands B Amendment: The Greenlands B area in the By-law is intended to identify significant woodlot areas. Staff has reviewed some of these boundaries, particularly as it relates to residential lots and are refining the boundaries of the Greenlands B zone to more accurately reflect actual woodlot boundaries.
