

Motorcyclist struck by car on No. 10 Sideroad

A Halton Hills man is lucky to be alive after he was thrown from his motorcycle in a collision with a Milton motorist Sunday afternoon.

The 52-year-old motorcyclist, who has just been released from the hospital, was traveling westbound on No. 10 Sideroad, east of Third Line South, in Halton Hills just before 1 p.m.

when the collision occurred.

Halton Regional Police said a Pontiac Sunbird being driven by a 49-year-old Milton woman was traveling in the opposite direction and suddenly turned northbound in front of the motorcycle while attempting to enter Andrews' Scenic Acres.

The two vehicles collided and the man was thrown from his motorcycle, landing in the grass on the north side of the road.

The motorcyclist was transported to Milton District Hospital and then later airlifted to Toronto's Sunnybrook Hospital, where he received treatment for injuries to his head, chest

and back.

The driver of the Sunbird was taken to Milton District Hospital with non-life-threatening injuries.

At this point no charges have been laid, but the investigation is continuing.

NOTICE OF PASSING OF BY-LAW

TAKE NOTICE THAT the Council of the Corporation of the Town of Milton passed **By-law Number 104-2005** on the **8th day of August 2005** under Section 34 of The Planning Act, R.S.O. 1990, as amended.

AND TAKE NOTICE THAT any person or agency may appeal to The Ontario Municipal Board in respect of the By-law by filing with the Clerk of the Corporation of the Town of Milton, **not later than the 1st day of September 2005** a Notice of Appeal setting out the objection to the By-law and the reasons in support of the objection and must be accompanied with a cheque of \$125.00 payable to the Minister of Finance required by The Ontario Municipal Board.

Only individuals, corporations and public bodies may appeal a zoning by-law to The Ontario Municipal Board. A Notice of Appeal may not be filed by an unincorporated association or group. However, a Notice of Appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

EXPLANATORY NOTE

By-law No. 104-2005 amends the Town of Milton Comprehensive By-law No. 144-2003, as amended.

This By-law affects all lands within the corporate boundaries of the Town of Milton. The effect of this By-law is to provide minimum development standards for residential dwellings related to road standard, water and wastewater servicing, utility connections and stormwater management facilities. These minimum standards must be provided for prior to any building being erected, used or occupied.
