Halton Region officials are looking to make Dinewise - a program where restaurants voluntarily disclose the results of their inspection reports — mandatory for Halton food establishments. Not a bad idea.

Approximately 550 restaurants in the region currently take part in the program in which an inspection certificate is posted prominently in the restaurant.

Customers can also ask to see the latest inspection reports.

Region staff is expected to report back to council in October with recommendations on making Dinewise mandatory after receiving comments from local restaurant operators.

> Restaurant owners were surveyed by phone last year on making Dinewise mandatory. Of those taking part in the voluntary program, 84 per cent supported making the program mandatory; only 65 per cent of non-participants were in favour.

In another portion of the survey, 81 per cent of respondents said having information about food safety inspections would influence their decision on where they eat - even more incentive for restaurants to meet safety standards.
