



Pit bull case to be heard in new year

The fate of a pit bull that bit a Milton boy last summer won't be decided before January 9, the date set for the owners' court hearing.

The date was determined Monday at Milton Provincial Offences Court.

"An application has been made seeking the court's guidance on an order to destroy the dog or (place restrictions on it)," said prosecutor Hal Watson.

An interim court order is currently in effect, which places strict conditions on the dog including that it not leave its owners' property except for veterinary care.

Nine-year-old Chazz Stewart was bitten on the hand in July by the male pit bull named Loco.

At the time of the incident, the dog was being cared for at the Milton home of the dog owner's parents.

Loco's owner, Scarborough resident Jackeline Perez, as well as her mom, Bianca, and Castano Perez, one of the property owners, have been charged under section 5.1 of the Dog Owners' Liability Act (DOLA) for failing to use reasonable steps to prevent the dog from biting.

Fines could be imposed

In addition to the possibility of the dog being destroyed, the Perez family could face fines.

At the court appearance, a proposed amendment to the interim order — to allow the dog to leave its property to go to obedience school — was rejected after animal control officers from the Oakville Humane Society objected based on concerns for the community's safety.

The Oakville Humane Society is contracted by the Town of Milton to provide animal control services.

Chazz had been walking home from a nearby friend's house when he was bitten in front of the dog's home at the corner of Dixon Drive and Pearson Way.

The dog hadn't been muzzled in accordance with Milton's animal control bylaw, nor was it licensed.

After a couple of visits from animal control officers, the humane society took the unusual position that the dog should be destroyed.

Chazz was at the courthouse along with his mom, Trudy.

He held up his right hand to reveal a large scar running across the base of thumb.

Ms Stewart said he's having a lot of trouble with his handwriting at school, despite using a rubber grip on his pencil.

In addition to the charge laid under DOLA, charges were laid under Milton's animal control bylaw for failing to muzzle a pit bull and permitting a dog to bite a per-

Fines of \$600 were imposed and have already been paid.

The hearing will take place at 10:30 a.m. at the Milton courthouse on Nipissing Road.
