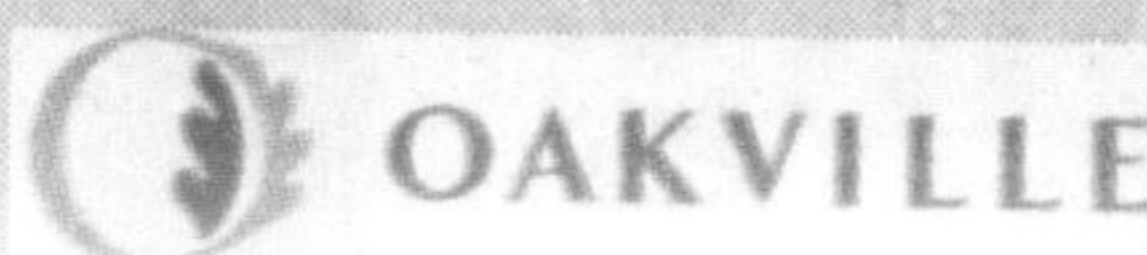

CLASS ENVIRONMENTAL ASSESSMENT STUDY

**Trafalgar Road to Regional Road #25
(Including a Section of Fourth Line)**

NOTICE OF FILING OF ENVIRONMENTAL STUDY REPORT

Lower Base Line between Trafalgar Road and Regional Road #25 (including a section of Fourth Line) is a two lane rural road. It is designated as a collector road and crosses two main tributaries of the Sixteen Mile Creek. In order to address the poor condition of the existing bridges (Barnstable Bridge and Henderson Park Bridge), slope stability concerns where the road is in close proximity to the creek, and road conditions in general, the Town of Milton and the Town of Oakville have completed a study of Lower Base Line (from Trafalgar Road to Regional Road #25, including a section of Fourth Line), in accordance with the Municipal Class Environmental Assessment (Class EA) process, which is approved under the Ontario Environmental Assessment Act.

Taking into consideration the problem being addressed, the assessment of alternatives and potential environmental effects, comments from agencies and the public, and incorporating a high level of mitigation, it is proposed to reconstruct Lower Base Line as a 2 lane collector road and to replace the 1 lane bridges (Barnstable Bridge and Henderson Park Bridge) with 2 lane structures. While Lower Base Line will generally follow the existing alignment, it is proposed to realign Lower Base Line from Barnstable Bridge easterly for approximately 1 km to avoid a section where existing slope stability is of concern.

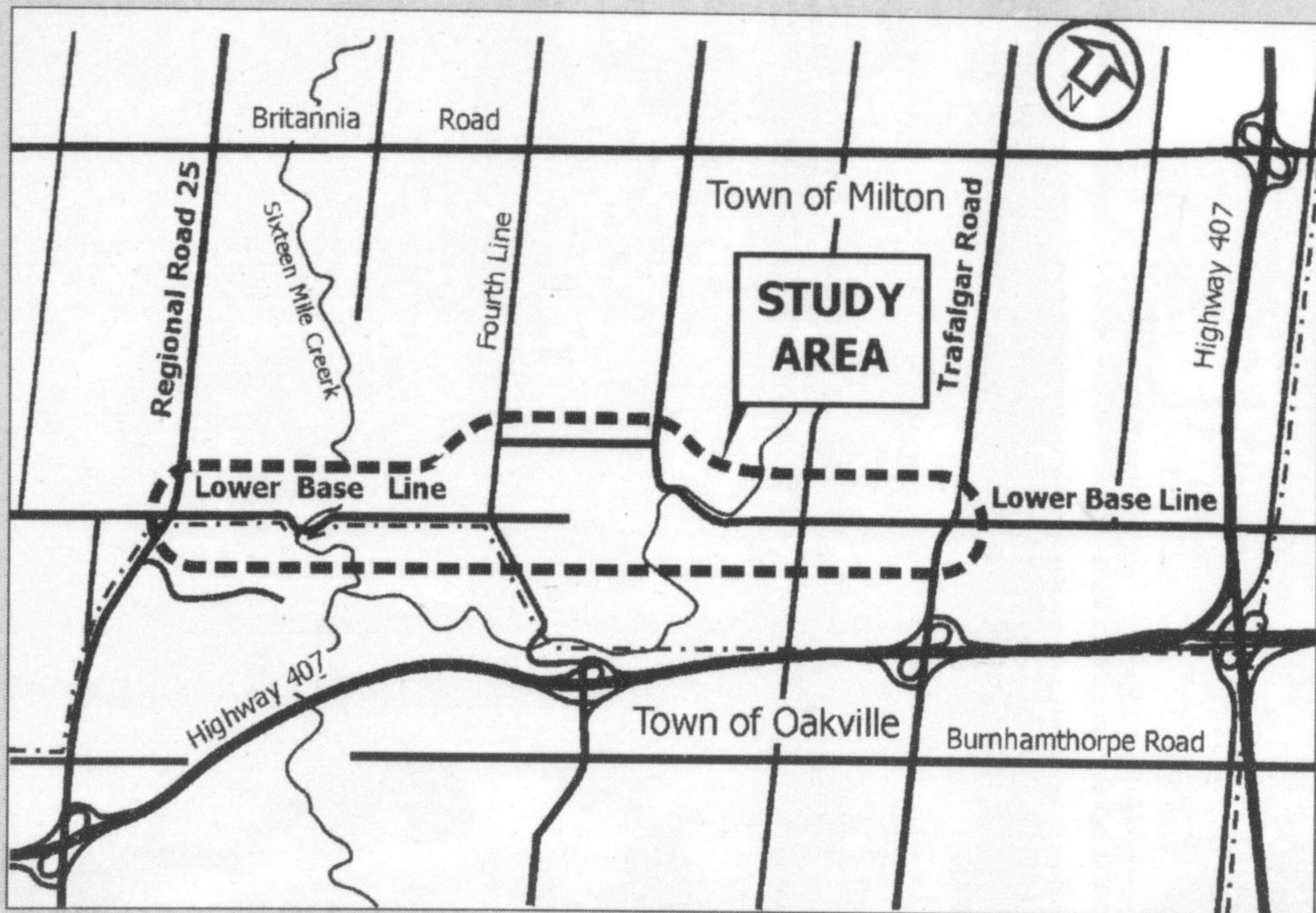
The nature of the recommended undertaking identifies it as a Schedule 'C' under the Municipal Class EA Process. An Environmental Study Report (ESR) has been prepared and by this notice, is being placed on the public record for review for a 30 day period in accordance with the requirements of the Municipal Class EA. Subject to the comments received as a result of this Notice, the Town of Milton and the Town of Oakville intend to proceed with implementation as identified in the ESR. If concerns regarding this project cannot be resolved in discussion with the Town of Milton or the Town of Oakville, a person may request that the Minister of the Environment make an order for the project to comply with Part II of the Environmental Assessment Act (this is referred to as a Part II Order), which addresses individual environmental assessments. Requests must be received by the Minister at the address below by February 6, 2006. A copy of the request must also be sent to the Project Coordinator for the Town of Milton or the Town of Oakville. If no request for a Part II Order is received by February 6, 2006, the project will proceed as outlined in the ESR.
