NOTICE OF ROAD RECONSTRUCTION AND TEMPORARY ROAD CLOSURE

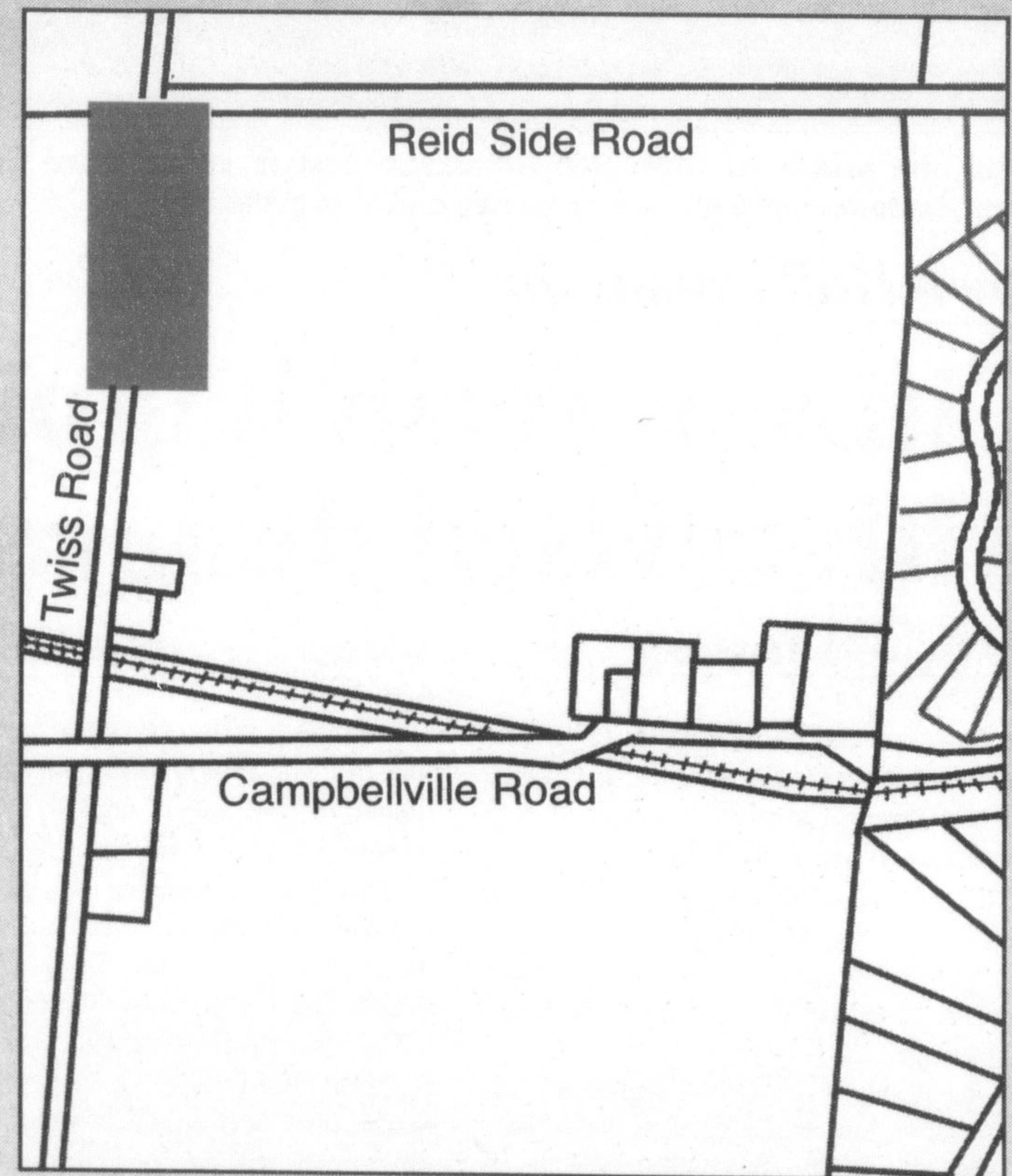
TWISS ROAD
(From Campbellville Road to Reid Side Road)

Notice is hereby given pursuant to Section 11(2) of the Municipal Act, S.O. 2001, Chapter 25, as amended, that the Council of the Town of Milton at its meeting to be held in Town Hall, 43 Brown Street, on January 30, 2006 beginning at 7:30PM will consider the adoption of a bylaw authorizing the reconstruction of TWISS ROAD from REID SIDE ROAD to 260 metres South of REID SIDE ROAD. Such a bylaw will also allow a temporary road closure to through traffic. Local access will be maintained throughout the proposed construction. Plans detailing the project are available for viewing between 8:30AM and 4:30PM at the Engineering Services Department at 555 Industrial Drive.

At this meeting, any person with unresolved concerns regarding the proposed work may appear to present their concerns to the Committee. Persons wishing to be heard must notify the Clerks Department in writing, no later than noon January 30, 2006.

NOTICE: UNCLAIMED DAMAGE DEPOSITS

The following is a list of unclaimed monies for damage deposits that were collected for work on private property affecting Town of Milton road allowances and other properties. According to Town by-law 31-94, all monies remaining unclaimed for a period of six years from the date of deposit, may be transferred to the general funds of the Town, provided that a notice containing a list of such unclaimed

monies, including the names of the depositor is published.

This notice is to inform all persons having any claim to any of such monies are required to prove their claims within ninety days from the publication of this notice. Upon the expiration of ninety days from the publication of this notice, the Town Treasurer may transfer all of such monies against

which no claim has been made to the general funds of the Town, free of and from any and all claims of any kind whatsoever. Where monies are claimed as a result of said notice being published, an administration fee of 10% of the amount of each deposit plus G.S.T. shall be deducted before any monies are refunded.
