NOTICE OF STUDY COMMENCEMENT

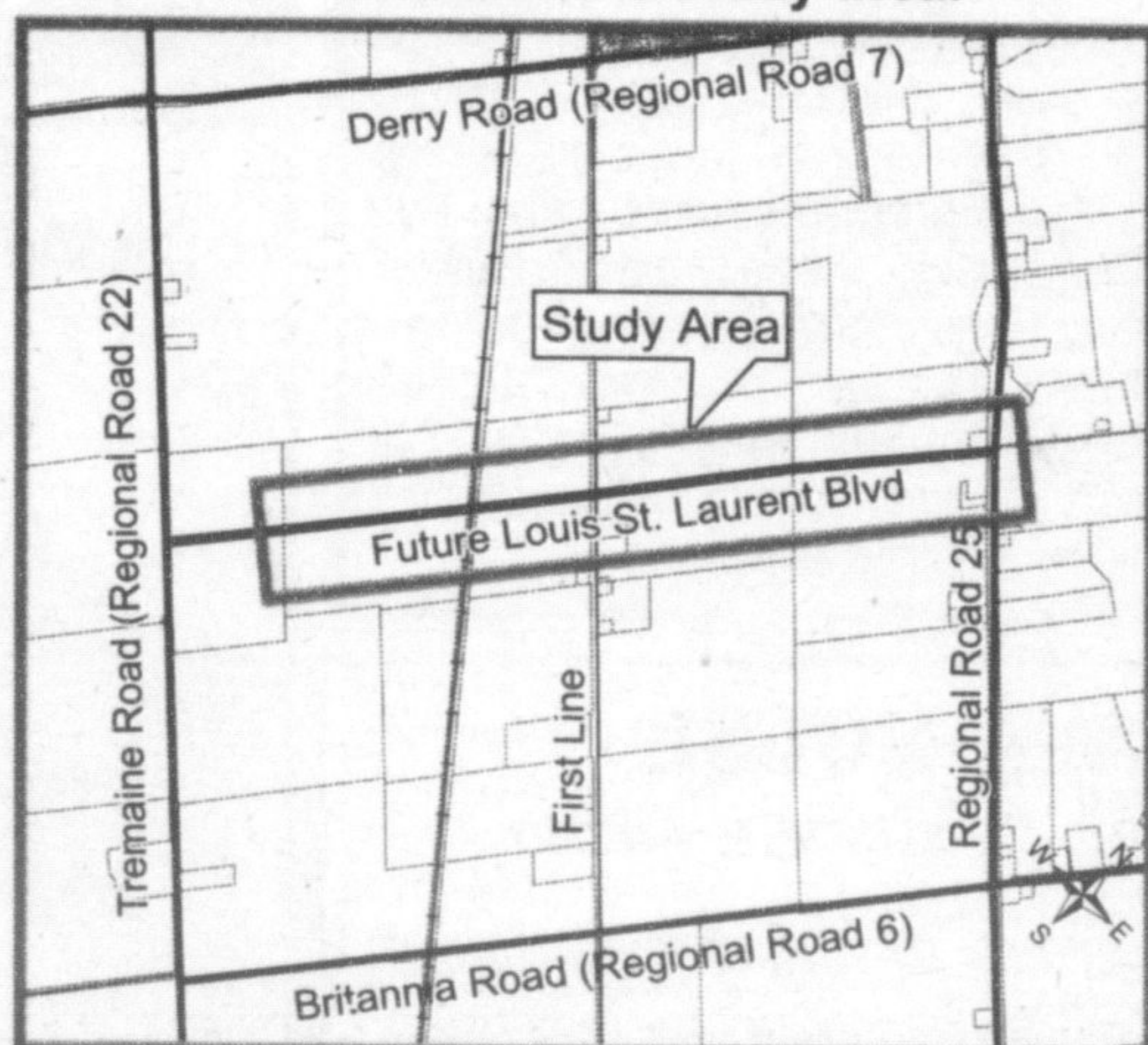
Sanitary Sewer Main and Sewage Forcemain on Future Louis St. Laurent Drive from Approximately 420 Metres East of Tremaine Road to Regional Road 25, Town of Milton Class Environmental Assessment Study

The Regional Municipality of Halton is initiating a Class Environmental Assessment (EA) for a sanitary sewage forcemain and gravity sewer linking the future Sherwood Survey Wastewater Pump Station located on future Louis St. Laurent Drive to the existing trunk sewage system on Regional Road 25. The requirement for infrastructure improvements was identified in the Halton Water & Wastewater Master Plan Review (March 2003).

This notice signals the commencement of the Class Environmental Assessment – a study which will define the problem, identify and evaluate alternative solutions, and determine a preferred solution in consultation with regulatory agencies, and the public. The study is being conducted in compliance with Schedule B of the Municipal Engineers Association (MEA) Municipal Class Environmental Assessment (June 2000), which is approved under the Ontario Environmental Assessment Act. The Master Plan Review completed Phase 1 and a portion of Phase 2 of the Class EA planning and design process.

A key component of the Class EA will be consultation with interested stakeholders (public and regulatory agencies) and providing an opportunity to meet the Project Team, review the project scope and address issues related to the project including alternative solutions, environmental considerations and evaluation criteria.

The map below shows the approximate limits of the study area.

Blue Box Collection	
Last Wednesday B Collection Date	Wednesday, January 25, 2006
New Wednesday A Collection Date	Wednesday, February 1, 2006 *Blue Boxes will then be collected every other week

These households will continue to receive Wednesday garbage collection and have their Blue Box collected every other week.
